Colton's Corners is newest West Side neighborhood

Colton's Corner, a 23-acre tract of West Side property commonly called "the old airport property," will be incorporated into the Seven Lakes West Landowners Association [SLWLA], Legal Director Hugh Beckwith announced during the Association's Tuesday, November 28, general meeting.

Ron Myers of Village Properties in Pinehurst will be subdividing the property into conventional one-acre homesites, Beckwith said. An earlier proposal by another developer would have placed higher-density cluster homes on the site.

"These will be the largest lots in the community outside of Morgan Wood," Beckwith said.

Noting that there are already problems associated with rain-

water runoff from the airport property, Beckwith said the development design will include a sub-surface drainage infiltration system for each lot that will capture run-off from the roofs up to a 25-year storm. "This will have a salutary affect on the homes downstream and, ultimately, on the lake," he added.

"We are very pleased with Mr. Myers' site plan," Beckwith said.

The Association has purchased from Myers an acre on either side of the back gate, which

creates space for an expansion of the gate or addition of a gatehouse in the future. The price for both parcels was \$10,000, which

SLCC approves driving range

In a vote finalized on Tuesday, December 5, the membership of Seven Lakes Country Club [SLCC] approved the construction of a new driving range by a 127 to 86 margin, SLLC Board president Dick Weber told *The Times* Wednesday morning.

Of the 298 members eligible to vote, 213 cast ballots, a better than 71% turnout.

Asked about next steps, Weber said a design for the new range has been finalized. "We look foward to working with all the people in the community to make it a satisfactory venture," he added. Weber said the club is looking at a number of options for financing the construction of the new driving range, which is expected to cost \$125,000.

One of the possible sources of cash to finance the new range is the sale of the existing five-acre driving range to a developer. A cover letter that accompanied the SLCC ballot mentioned this option and generated concern in a number of quarters — not the least among the members of the board of the Seven Lakes Landowners Association [SLLA].

The SLLA board sent a letter last week to its membership expressing its opposition to the residential development of the existing range — and noting that he board's attorney's believe that the community's covenants prohibit the development of the parcel

Moore County's Board of Commissioners gained three new members Monday afternoon and elected its most senior member to the post of chairman

Larry Caddell, Jimmy Melton, Cindy Morgan were sworn in as commissioners before a crowd that more than filled the historic Moore County in Carthage. They join veteran commissioners Tim Lea and Colin McKenzie — the panel's new chairman — on the board.

The ceremony was very much a family affair. Morgan's father, Fred Richardson, of Community Baptist Church, gave the invocation. Her mother by her side, Morgan was sworn in by her husband, State Representative
— and former Speaker of the
State House — Richard Morgan.

Moore County Clerk of Superior Court Catherine Graham handled the swearing in of Caddell and Melton, who were both surrounded by a crowd of family

With the three new commissioners seated, the board got down to business; and the first order of business was passing a resolution honoring the lifetime of service of former commissioner Robert Simmon Ewing, who died a few weeks ago.

The resolution, read by Commissioner Tim Lea and written in large part by Seven Lakes' Car-

Bust recovers pills from local robbery

An undercover investigation into crack cocaine trafficking has led Moore County Sheriff's officers to a cache of drugs that apparently were stolen from the Seven Lakes Prescription Shoppe more than a year ago.

Working with Sanford Police and the Lee County Sheriff, Moore county investigators arrested 26-year-old Bobby Joseph Pusser on a Federal narcotics warrant and searched his residence at 855 Juniper Lake Road.

They found approximately 7,800 prescription pills, 229 grams of liquid oxycodone, 147 grams of marijuana, one gram of powder cocaine, a .380 caliber handgun, \$1,195 in U.S. currency, and items of drug paraphernalia, according to the Sheriff's Office

The prescription medications

were determined to be among those reported stolen to the Moore County Sheriff's Office in November of 2005, from The Prescription Shoppe Pharmacy on Seven Lakes Drive.

The 7,800 pills seized included approximately 3,963 were Methadone pills, 1,582 Morphine pills, and 235 Oxycodone

Total estimated street value of all drugs seized is \$140,000.

London Archie McRae, 41, of 4456 Carthage Road in West End was also arrested on Federal charges for distributing crack cocaine.

The Federal cocaine trafficking charges stemmed from an undercover investigation conducted by the Moore County

Sheriff's Office Narcotics Unit. During the investigation approximately 43 grams of crack cocaine was seized with an estimated street value of \$4,000.

Pusser and McRae were transported to Greensboro, North Carolina and placed in the custody of the U.S. Marshall's Service and detained.

Master Kleen celebrates 20th birthday

Eighty-seven years of experi-

That's a lot for two guys.

But eighty-seven years of experience is what Jack and Ricky Embler of Master Kleen in Seven Lakes have between them as the dry-cleaning establishment celebrates its twentieth

anniversary this month.

Master Kleen opened its Grant Street shop in 1986 — a month before the street was blacktopped.

Mary Edna Lawrence — wife of Seven Lakes developer Fred Lawrence — was a loyal customer from the start. "She told

Fred she was tired of driving down a dirt road to pick up her cleaning," Jack Embler told The Times. "Just a few weeks later, the street was paved."

Jack Embler spent 31 years in the dry cleaning business in High Point before moving to Seven Lakes. Why the move?

Embler told The Times that he was in the habit of coming down to Seven Lakes to play golf.

He knew local Realtor® Harvey Reed, who was a customer of Embler's High Point cleaning business.

"Harvey said, 'Let me set you up in a house — then you'll have some place to stay when you come down to play golf," Embler explained. "That very weekend I bought the log house on Shadywood — where I still live."

That was in 1981. Embler opened Master Kleen in 1986. "And we've been here ever since." he added.

"We were the first business back here," he told The Times. "The only other businesses here were up on 211 in the business village area."

He noted that two other Seven Lakes business pioneers -

Kenny Mace and Jimmy Stackhouse - handled the electrical and plumbing work for the MasterKleen building.

Though Master Kleen is very much a Seven Lakes business, owned and operated by Seven Lakers, nearly half of their customers come out from Southern Pines and Pinehurst in order to take advantage of the quality service the Emblers provide, Jack Embler told The Times. They also serve customers from Carthage and Robbins, as well as from Troy, in Montgomery





Pottery studio makes it easy to be crafty

"This is just so much fun," Lori Ivan tells a reporter. "People come in, sit down, start working and, after a while they'll say 'This is just so relaxing."

Some new meditation technique, maybe?

A new kind of exercise? Guess again.

Ivan is the new manager of the new Seven Lakes location of the 9th of September, a paint your own pottery studio.

The store, which is located in the Central Park Building on Seven Lakes Drive — near Seven Lakes Massage and Body opened on November 20, owner Eugenie Wing told *The Times*.

Wing has owned the Southern Pines studio of The 9th of September for 15 years. She told *The Times* that she is pleased with the response the new shop has generated among Seven Lakers.

"What a great community this is," Wing said, noting the warm welcome she has received from both the business community and residents.

The paint your own pottery idea is simple: you pick out a plain white cup or bowl or figurine or holiday ornament. The studio provides the paint and brushes. You supply the creativity. Once your creation has dried, it is dipped in a clear glaze, dried, and the fired in a kiln at over 1800 degrees. You pick it up at the shop a couple of days later.

The idea is simple, but the possibilities are endless, limited only by the customer's talent and imagination.

Ivan is quick to note, however, that you don't have to be an artist to have fun at The 9th of September. "We have idea books, and stencils, and stamps that can help you along," she told

The Times. "No artistic talent is necessary."

It's a relaxing, fun experience for both adults and children, Wing said. So that makes it an ideal outing for grandparents entertaining grandchildren visiting for the holidays. And there's no need to worry about ruining your holiday sweater, because the paints are all water-soluble and wash right out.

"Sometimes children will come with their grandparents and make a special cereal bowl that they can use whenever they visit," Ivan said. Once they are fired all the 9th of September items are food safe, microwave safe, and dishwasher safe.

Because the items are handpainted by the giver, they make outstanding holiday gifts for other family members.

Prices range from three dollars for a small holiday ornament or tile to forty dollars for an ornate cookie jar.

The brightly colored studio is filled with small tables with checked tablecloths that provide ample space for customers — and can be reserved for

Ken Hale elected to RIT Hall of Fame

Southsider and former student-athlete Ken Hale was recently inducted into the Rochester Institute of Technology [RIT] Sports Hall of Fame, in

Rochester, NY.

Hale made quite an impression during his three years on campus. He was a key component in RIT's only undefeated basketball

An imposing presence on the floor, standing nearly 6'7," Hale's agility allowed him to run the

effectively from the outside. He scored 500 points in a single season, accomplishing this

feat in only eighteen games.

And he finished his career at RIT with 1,044 career points, ranking him at seventeenth place on the school's all-time scoring list. Hale was the first basketball player in the Rochester area to break the 1,000-point career

Hale is a native of Rochester "born, there, grew up there, and lived 62 years there," he told The Times. Before moving up to RIT, he was center on the Monroe High School team.

The Rochester area was a real hotbed for basketball in the 1950s, Hale said, and was even home to a professional team — The Rochester Royals — back in the days when there were only eight teams in the whole pro basketball universe.

That meant Hale could spend his summers playing basketball against the pros.

The Royals, after several moves from city to city, are now the Sacramento Kings.


America squad.

Red Cross urges heating season caution

As temperatures start to dip across the country, the American Red Cross urges families to be cautious when using space heaters and other heating sources, and to plan ahead for the possibility of a home fire. Home heating fires increase during the late fall and winter months, and portable heating fires are more deadly than oth-

A recent Red Cross poll found that nearly half of American families use heating alternatives such as a space heater, fireplace or wood/coal stove to stay warm.

Fires kill more Americans each year than all natural disasters combined, and the Red Cross urges families to develop a fire escape plan and to take steps toward fire prevention and safe-

To prevent heating related fires, the Red Cross recommends keeping all potential fuel sources, including newspapers, matches, bedding and clothing, at least three feet away from heat sources such as a space heaters, fireplaces and wood stoves. In addition, portable heaters and fireplaces should never be left unattended.

Read and follow the manufacturer's instructions on how, when and where to safely use heating equipment, such as space heaters and wood stoves.

"Ever year in Moore County, home fires are the single most common disaster threat," said Buddy Spong, Executive Director. "In fact, the Moore County Chapter responded to more than thirty-five home fires last year here in Moore County, and provided 116 fire victims with immediate emergency assistance."

"The good news is that preparing for a home fire doesn't require a lot of expensive equipment or training," said Spong.

"In addition to functioning smoke alarms, one of the easiest ways to prepare is to develop and practice a home fire escape plan so that every family member, including young children and the elderly, can escape quickly and safely."

Fire escape plans include at least two exit routes for every room in the home, and a convenient meeting place at a safe distance from the fire. Escape ladders should be used and stored near windows in floors above ground level, and all family members should know how to locate and use the ladders safely. Families should practice their escape plan at least twice a year.

Whenever a home fire occurs in our area, the Moore County Chapter provides fire victims with assistance for food, clothing, and temporary shelter. This relief is made possible by generous donations from people throughout Moore County.

Simple Tips to Prevent Home Heating Fires

Keep all potential fuel sources (newspapers, matches, bedding, clothing, carpets and rugs) at least three feet away from heat sources, such as space heaters, fireplaces and stoves.

Provide constant adult supervision in rooms with lit candles or fires.

Keep fire in the fireplace by using glass or metal fire screens.

Never leave a fire in the fireplace unattended. Extinguish the fire before going to bed or leaving the house.

Never use a cooking range or oven to heat your home.

Turn off portable space heaters every time you leave the room or go to sleep.

Have wood and coal stoves, fireplaces, and chimneys inspected annually by a professional, and cleaned if necessary.

If you must use space heaters, place them on a level, hard and nonflammable surface such as ceramic tile floor, not on rugs or carpets or near bedding or drapes. Keep children and pets away from space heaters.

Kiwanis hear about hospital infection rates

The Seven Lakes Kiwanis Club members sat in rapt attention at their regular weekly meeting on Tuesday, November 28. Speaker Jayne P. Lee, Administrative Director of Clinical Performance for FirstHealth of the Carolinas Moore Regional Hospital, gave an excellent presentation on infection rates in hospitals and the current media attention concerning this issue.

Pennsylvania is the first state to publicly report the number of patients who contracted an infection while in one of its 168 hospitals during the past year. It was hoped this would boost efforts for public reporting of hospital quality data reports nationwide. Currently about sixteen states are covering a variety of infection report requirements, however, none have as yet issued a comprehensive report.

Lee, who oversees case management, quality, and infection control for FirstHealth of the Carolinas Moore Regional Hospital responded that FirstHealth is aware of the need for appropriate and effective reporting of hospital quality data.

Dr. Jeff Engel, NC State Epidemiologist, is prominently involved with input, oversight and comparisons in a study bill currently under review by the North Carolina legislature. First-Health is monitoring this bill for methodology, fairness, comparison, implementation, and input.

stated that the single most important element for preventing infection in the hospital is frequent hand washing. If you are a hospital patient, you must take the initiative and not hesitate to suggest to all medical personnel if they have neglected hand washing protocol to please wash their hands before treating you.

Lee also explained that plain regular soap and water is a

superior vehicle for infection control rather than the antibacterial soap frequently used in homes. Also for household cleaning, bleach is still the best for germicidal action.

If and when the North Carolina legislature enacts a bill to mandate reporting of hospital quality data, an important step in patient well-being will have been taken.

Doctors get new 'eyes'

Two new angiography machines at FirstHealth Moore Regional Hospital are allowing physicians to diagnose blocked arteries and other problems in non-cardiac blood vessels with much greater precision.

The new equipment also enables physicians to treat some of those problems more effectively and with less risk to the patient.

The hospital has opened a new suite exclusively for angiography procedures. Both of the suite's new angiography machines have state-of-the-art digital-image intensifiers, which give physicians extremely clear, detailed views inside arteries and veins.

"It's like going from a television with a picture tube to a digital, flat-screen television," says Lawrence Martin, M.D., an interventional radiologist at Moore Regional. "The difference in clarity is that great."

Angiograms are electronic images of blood vessels that can show the location and severity of blockages, which are usually caused by the build-up of plaque. Angiography is used most often to diagnose obstructions in arteries in the legs and in the renal arteries and carotid arteries, which supply blood to the brain.

By injecting a contrast material into the vessels they want to study, physicians can see where blood flow is normal and where there is a problem. They can

then use minimally invasive techniques to open the vessel and restore blood flow.

"Because of the greater clarity, we can now do all this faster, more efficiently and with greater patient safety," Dr. Martin says.

According to Robert Albrecht, M.D., a vascular surgeon, the new equipment has greatly improved the ability to diagnose and treat obstructions, aneurysms and other problems in vessels that are far below the surface of the skin.

"It particularly helps with the deeper blood vessels, such as those in the chest and abdomen," he says. "The images we get now are superb."

When physicians find a blocked or narrowed vessel, they often use a balloon catheter to push the plaque out of the way or a cutting device to shave plaque off the inside walls of the vessel. Sometimes, stents are inserted to keep the vessels open.

Placing stents in carotid arteries has always been done by surgeons in an operating room. But for some patients, it now requires only a minimally invasive procedure in the angiography suite.

According to Dr. Atkinson, Moore Regional's new angiography equipment symbolizes the hospital's commitment to invest in the newest and most advanced technology.

Decently and in order

Things got a mite testy at last Tuesday night's meeting of the Seven Lakes West Landowners Association.

Questions were hurled at the board from unidentified speakers in the back of the room. A few comments that could be characterized as accusations were hurled. as well.

The tempers of more than one member of the board began to fray. Board members shooting from the hip in response to questions provided seemingly contradictory information. And, yet again, someone accused the board of using "scare tactics."

For those with some history in the community, it harkened back to some of the more acrimonious West Side Landowners Association meetings in the late-90s, when you couldn't hear over the fans in the Beacon Ridge clubhouse, the summertime temperature rose apace with the tempers, and general shouting matches were too often the order of the day.

It's understandable that folks on the West Side are wary. They've just been through a divisive debate on the North Carolina Wildlife Resources Commission. Many wanted more information as negotiations progressed and more involvement in the decision-making. The SLWLA board, though gathering plenty of public input, negotiated and decided the issue largely out of the public view.

That process was certainly the Board's to define, but it may have made folks a bit concerned that they are being left out of decisions. That suspicion is likely to fade in time, as the board continues to evidence its openness to input.

But the relationship between the board and the landowners they serve will not benefit from many more acrimonious meetings like last Tuesday's.

Fortunately, there's an easy fix: Make sure every speaker uses the microphone.

Tony Robertson has been working on this for some time, with more or less success, depending on the meeting. As he often notes, he's hard of hearing, and so needs the amplification if he's to catch what's going on in the meeting. Many other residents are in the same boat. Other folks, including the press, would like to know the identity of those who are offering comments or asking questions.

But, beyond that, when speakers are forced to walk ten or twenty feet from the back of the room to the mic and then give their names and their addresses. that process has the salutary effect of giving them time to think about what they are going to say and how they are going to say it — before they start speaking.

It's a public meeting implementation of the old rule about counting to ten before you say something in anger.

And it's a rule that should apply to board members as well. A board member who wants to respond to a landowner's comment or question should signal the moderator and proceed to the lectern to make that comment — not engage in debate from his or her seat.

That way, everyone will be able to hear the board member's response, and the board member, by going through the process, will benefit from the same helpful "count-to-ten" principle.

This is such a simple idea, we're almost embarrassed to be writing a whole editorial about it. In fact, it's pretty much a matter of common courtesy.

On the other hand, it is amazingly hard to get folks on either side of the table to actually do it.

The only way to make it happen is to brook no exceptions and to insist that speakers play by the rules.

And the responsibility for taking that hard line rests with whomever is moderating the public input session — usually the board President.

If folks on both sides of the table would play by these rules, the level of acrimony in SLWLA general meetings could be reduced substantially.

Folks will still disagree, and still get upset, of course, but those disagreements and concerns will have a better chance of being effectively articulated and answered if everyone takes the time and makes the effort to ensure that all things are "done decently and in order."

This past September one of the senior high school classes where I taught for thirty years or so had a reunion. It was the class of 1956 and they were having their 50th reunion.


I already keep up an email correspondence with six of them and exchange Christmas cards with two more of







Beckwith called "a very fair price."
SLWLA President Jim Meikle said the deal is the result of several months of negotiating by Beckwith and Community Manager Tony Robertson.

President's Report. Meikle began the meeting by asking for a moment of silence in honor for service men and women who must spend this holiday season overseas in harm's way.

On behalf of the SLWLA Board, he wished all landowners "a very happy holiday season, filled with delights of the season."

Lakeway Pond. Meikle reported that the lower pond in the Lakeway Boulevard mall had sprung a leak and emptied out on Thanksgiving morning.

The cause was much the same as the problem that emptied out one of the Lakeview ponds two years ago. He explained that the spillway that caries water from the pond under Longleaf Drive is constructed of a standard corrugated steel pipe. Over time, the pipe has rusted out, allowing the pond to drain.

Based on the Board's experience with Lakeview Pond — which took longer than expected to repair — Meikle said the new leak should be repaired in a couple of weeks. The same contractor who handled the repairs two years ago is handling the job.

"We have one remaining pond," Meikle added. "Sooner or late the Carriage Pond will drain itself. We now know what to do and how to go about doing it."

Later in the meeting, during Infrastructure Ray MacKay's report. Ronnie Milligan asked whether bids had been taken on the pond repair.

MacKay said no bids were solicited because the bidding process itself would take two months. "We invited the contractor that we used before — who knew what to do — to come in and do it," MacKay said. "In emergencies, taking bids doesn't really get the job done if you know what you want."

He estimated the repairs would cost roughly \$5,000.

The lower pond is spring-fed from the upper pond, MacKay said, and the water from the pond is used to irrigate the Lakeway mall. MacKay said he felt it would refill relatively quickly.

Adopt-A-Road. Meikle thanked Jo Kinney for her efforts on the Adopt-a-Road program and noted that there is still an opportunity for volunteers to sign up to look after particular stretches of roadway, particularly along Longleaf Drive. Kinney can be contacted at 673-0091 or 673-2571.

Meikle also thanked Roger and Ruth Brooke and the decorating committee for "the great West Side Park Community Center decorations."

Manager's Report. Tony Robertson announced that donations boxes for the US Marine Corps' Toys for Tots campiagn have been placed at the Community Center and in the mailhouse. Noting that the response had been somewhat disappointing thus far, he encouraged residents to contribute a toy.

Finance. Treasurer Virgil Reid provided printed reports of the status of Association funds and performance against the Association budget. The SLWLA currently has roughly \$1.5 million in the bank.

Reid noted that landowner Pete Staaf had asked a question during the October General Meeting about the use of an audit of the Association's books versus an accountant's review, which is the current practice. Staaf later expressed his concerns in a Letter to the Editor published in the November 22 edition of *The Times*, in which he noted a lack of accounting experience on the SLWLA board.

"I told him at the time that I had experience in accounting," Reid said. "I said that I had experience in accounting before entering general management."

Reid noted that he had majored in business administration with a concentration in finance and had in fact worked in finance from his graduation in 1969 to 1991.

He also said that Hugh Beckwith is the Chief Financial Officer for a group of companies.

"Don't let this letter lead anyone to believe that we don't have accounting experience on this board," Reid concluded. "It's not true."

Later in the meeting a landowner asked whether the board had decided whether to move to a full-fledged audit of the Association's books.

"The board has not had a

chance to sit down and review the pros and cons," Meikle replied.

Recreation. Recreation Director Betty Milligan noted that the Community Center will host a Holiday Event for children on December 16, from 1:00 pm to 2:00 pm. Children will be decorating gingerbread houses. Reservations and a fee are required.

Infrastructure. Director Ray MacKay said there will be a Christmas tree drop outside the boat and trailer storage area. Only Christmas trees may be dropped off, beginning January 1. Residents who need help can call MacKay or the office after January 1.

more general discussion of the board's exploration of home mail delivery.

Mike Finney explained that the board had formed a committee to investigate the pros, cons, and potential costs of home delivery last year. "That committee discovered a whole host of problems and questions," Finney said.

To gauge public interest, the committee inserted a question concerning the interest in home delivery into the mailing of Association dues statements this Spring. Finney said that only about ten percent of landowners responded to the survey, and the opinion was evenly divided.

"We are now in the process of regathering ourselves, with a plan to go back and look at the question with a more finite pen," Finney said. "We are trying to identify the costs, the pros and cons. Sometime in 2007 you will get the opportunity to decide if you want it or not with all the facts provided."

Hoffman asked whether the US

Postal Service had not refused to move to home delivery in the past.

"That is totally correct," Finney said. "What is required is a twostage effort. Number one -What is the desire of people? Number two — Can it be achieved?"

"We have gotten a flat no from the post office in the past," he added. "Some folks think it could be achieved."

Finney said the committee felt it would be important to standardize mailboxes, if curbside delivery were implemented. The projected cost, were the association to purchase and maintain them, was estimated to be \$230,000, Finney said.

Several residents objected to this estimate, arguing that it was inflated. One accused Finney of using "scare tactics."

"I have no dog in this fight whatsoever," Finney replied. "I could care less whether we have mailboxes."

He indicated the committee considering home delivery would be revived early next year to take another look at the issue.

Wildlife. Dr. Lionel Kuhn asked if there were any news on the situation with the North Carolina Wildlife Resources Commission.

"Only what you read in the last issue of The Seven Lakes Times," SLWLA President Meikle replied.

Kuhn said he was concerned about the question of whether the

Association would subject itself to additional liability by signing an agreement with the NCWRC. he asked whether the decision should be a matter for a referendum.

Meikle said that the SLWA will incur no more liability than it currently has by creating and enforcing rules.

"The Board has already made the decision," Meikle added.
