SLLA Board will move forward with repaving

Major road repaving in Seven Lakes North and South will begin as scheduled in Fall 2010, despite a recommendation from the Road Paving Subcommittee that repairs be delayed for an additional year.

The subcommittee recommended delay in order to allow time for additional reserve funds to accumulate. However, the Seven Lakes Landowners Association [SLLA] Board of Directors was equally unanimous in their bid to move the project forward as originally proposed, starting

with a few key areas that will what will be the price of oil, and require extensive repairs.

Reporting at the Monday, September 14 SLLA Board Work Session, Treasurer Denny Galford estimated the project would cost at least \$800,000, some of which will have to be borrowed

"The roads are solid," Galford said. "If we delay, the roads will not require any more repair work whether they are done in 2010, 2011, or 2012. But the excessive sealing work shows the age of the community. If we delay, there are unknowns -- what will inflation do to the interest rates,

what will be the price of paving?"

Director Bruce Keyser, Jr., who owns a small construction business, argued that costs were currently low but already creeping back up.

"We pushed to put in a dues increase [for road reserves], and I think residents want to see some action," said Keyser.

President Randy Zielsdorf, along with Directors Kent Droppers and Sally Kindsvatter, also argued in favor of kicking off the project sooner rather than later.

West Side will seek foreclosure for back dues

Foreclosure liens will be filed against several undeveloped lots in Seven Lakes West, reported Legal Director Ed Silberhorn during the Tuesday, September 8 Work Session of the Seven Lakes West Landowners Association [SLWLA] Board. Silberhorn recommended liens be placed on lots 5215, 4143, 4097, 4308, 5653, 5652, 6190, 6809, 4055, 3074, 3503R, 3502, 5671, 10, and 4196.

During a related financial discussion, a report of \$24,000 in

dues delinquent for at least eight months prompted criticism from Silberhorn.

"If the office knows of a problem, it should be brought to our attention," he demanded.

Community Manager Joan Frost countered that the information had been included as part of the complete monthly financial report.

Frost said she is working with Director Mick Herdrich to determine procedures for billing and collections next year - with consideration being given to a monthly or quarterly payment option for residents.

Treasurer Kathy Kirst expressed concern that budget revenue is based on cash flow.

"We're not evenly dispersed on a monthly basis with some expenses being very seasonal," Kirst said. "We need to schedule to get things in the budget and then will have to dovetail that in the decision on whether to offer quarterly or monthly [payments]."

Silberhorn said a major portion of the budget is manpower which is directly tied to whether the

DOT names consultant for crossing project

The Rail Division of the NC Department of Transportation [NCDOT] has hired a consultant to conduct environmental studies and produce designs for the upgrading of the rail crossing at Seven Lakes West's front entrance, as well as the closure of crossings in West End.

NCDOT Nancy Horne told *The* Times that former NCDOT Engineer Jason Field, now a staff consultant with Moffat & Nichol Engineers, will spearhead the project.

A large firm headquartered in California, Moffat & Nichol has two-dozen offices and 500 engineers worldwide. The firm was founded in 1945 to help build ports along the West Coast, but rail services is among their chief areas of practice.

Horne told The Times that the Seven Lakes-West End Rail Safety project is likely to involve at least one more opportunity for

public input, once Field's research is done and initial designs are complete.

It is likely, she told The Times, that the necessary public meetings will be held sometime after the first of the year.


Horne said she could not, at this point, project when shovels will actually be put in the ground to upgrade the Westside crossing.

The project will make the currently private crossing at Lakeway Drive and NC Highway 211 a public crossing and upgrade it with safety gate arms.

Crossings at Mode Road and Edgewood Terrace in West End will be closed. The closures are necessary so that federal rail safety funds can be used to pay for the project, reducing the need for state funds and the potential liability that would be associated with an accident at the Seven Lakes West Crossing.

Drug charges in West End

on charges of obtained drugs by "doctor shopping."


Ronnie Lawrence Brown, Sr., age 54, of 210 Woodlawn Street in West End was arrested on September 15 and charged with 25 counts of felony obtaining controlled substance by misrepresentation to a healthcare provider.

Detective Jerrell Seawell told The Times that Brown had obtained prescriptions from several doctors both in Moore County and elsewhere — a practice

he described as "doctor shopping."

According to a press release from the Sheriff's Office the investigation, which Seawell said stretched over a period of weeks, found that Brown had obtained Oxycodone, Oxycontin, Alprazolam, and Amphetamine Salt (Adderall), which are Schedule II, III, and IV controlled substances.

Brown was given a \$10,000 unsecured bond and released.

More delays on Woodland Circle Extension

Another problem with the culvert has further delayed work at the Woodland Road Extension project, reported Tom Collins.

Addressing the Foxfire Village Council on Tuesday, September 8, Collins said uninspected culvert materials were delivered to the site.

"That is a big no-no. You don't deliver structures without approval at the factory," Collins explained.

In addition, the subcontractor delivering the culvert material used Eagle Drive — in violation of the contract. Any future illegal hauling will be ticketed and fined.

Collins said he was waiting for the appropriate inspection paperwork to arrive before proceeding, however grading work would continue.

Stonehill Pines

Reporting on progress at the Stonehill Pines project, Collins said the developer is processing permits.

"They have had to back up and [re]design the storm water management plan. They had hoped to do it as an overall project but it was not allowed so they are breaking the project into pods, each designed with storm water management, drainage, and sanitary," Collins said.

"It will take more time and there is no time schedule yet."

Water

Councilman Ed Lauer initiated a discussion of a proposed, new policy to review excessively high water bills. The policy is in response to a complaint received last month that, despite many tests and theories, has concluded with no clear answer to why a resident's meter read so uncharacteristically high.

Lauer said he personally disagreed with forgiving water bills but was willing to accept the Council's request to create a policy that would allow for review and reconsideration.

Specific details were not discussed as Lauer was waiting for final comments from two Councilmen, however he said the final policy would be "very fair both to the user and the corporate structure."

Lauer said the new Village water meters – already installed for approximately 2/3 of customers - will detect leaks through

monitoring for constant water flow

Continuing the water report, Lauer called a motion to comply with a stipulation in the 2008 North Carolina Drought Ordinance requires a permit for all new irrigation systems. An auxiliary meter on the main residential meter is necessary.

"They are looking for enforcement. I can think of no other reason they would require when there is no sewer," Lauer said. "It is obvious that North Carolina is trying to get control of the water situation."

Approved unanimously, the law applies to all new, in-ground irrigation systems.

Finance

The General Fund cash balance is over \$400,000, reported Councilwoman Leslie Frusco,

including \$21,790 in the Stonehill Pines fund and \$26,838 in Powell Bill funding. The Water Fund stands at \$180,125 in unrestricted funds; an additional \$135,000 is held in a restricted account for a potential new well.

Annual loan payments of \$30,000 for the Village Green park project and \$41,000 for the Water Fund are due in July 2010. The first loan payment of \$96,304 for the Woodland Road Extension project is due April 2010.

Long Range Planning

Frusco said the Council has identified five key areas of concentration that will direct the newly formed Long Range Planning Committee. The eight member committee includes Rick Nappi, Ed Spaulding, Mike Siedler, Warren Morgan, Mick McCue, Steve Durham,

MaryAnne Lauer, and Mark Dutton. An initial meeting is scheduled for the end of September.

In other business, the Council heard:

Traditional look sought for county building

A more traditional look — that's what a committee asked to evaluate an architect's design for the new Government Center to be built in downtown Carthage recommended, and that's what the Moore County Board of Commissioners approved during their Tuesday, September 8 meeting.

The Government Center Committee, chaired by Planning Director Joey Raczkowski, had been asked to review schematic drawings of the building prepared by architects LS3P Associates based on extensive interviews with county departments.

The initial design proposed by the architects had a distinctly contemporary profile, with the Board of Commissioners meeting room positioned on one end of the building, and massive windows providing substantial natural light to the building's interior.

The committee wanted to preserve the natural lighting, Raczkowski told the Commissioners, but would prefer a more traditional look for the building -- one that would be more in keeping with the historic architecture of downtown Carthage.

Other recommendations of the committee included:

- Moving the Commissioners meeting room to the center of the building, with wings of offices on either side, creating a more traditional, symmetrical design.
- · Utilizing the natural slope of the property to create a sloped floor in the Commissioners' meeting room, creating theaterstyle seating.
- · Utilizing the vertical space

resulting above the Commissioners' meeting room to add a second floor in that part of the building, which could be outfitted for use immediately or held in reserve for later.

Adding a full basement below the structure, which would allow for climate controlled storage initially and could later be used for the expansion of work space. The architect's initial plan had called for a partial basement.

The Board voted three to one to accept the committee's recommendations, with Commissioner Cindy Morgan in opposition. Commissioner Tim Lea was unable to attend the meeting.

LS3P Associates will now be asked to redesign the building, County Manager Cary McSwain told Commissioners that he had

begun the process of negotiating the fee for that work, but was unwilling to publicly discuss the cost, noting that the initial proposal from the architects "may have had a misplaced decimal."

In a related vote, the Commissioners also approved the Master Plan for the development of the Grimm property, prepared by consultants Land-Design.

The plan shows the basic lavout of the site, including the positions of the buildings, internal roadways, and parking areas. LandDesign consultant Jeremy Rust noted that some details would be adjusted in the final lavout to reflect the redesign of the Government Center.

The plan was approved threeto-one, with Morgan opposed.

New wells to be drilled in Pinehurst

The Board also approved Tuesday afternoon a \$235,000 contract with Charles R. Underwood, Inc., for three new wells in Pinehurst. Utility Operations Manager Ben Vaughn explained that, even though Underwood was not the low-bidder on the job, the company had been successful in other cases of drilling through contaminated groundwater in order to tap uncontaminated water deeper in the around.

Two of the three new wells included in the contract are replacements for existing wells one of them closed because of groundwater contamination.

"The groundwater has a significant amount of radioalogical sands and clays that we have to avoid," Vaughn explained, noting that Underwood has a "trade secret" that helps them successfully deal with such challenges.

"We only get one shot on these," Vaughn said. "The Underwoods' track record and our working with them the past sixteen years has demonstrated that they are the most capable" of the firms bidding on the contract.

After County Attorney Misty Raines explained that the Board is not obligated to accept the lowest bid on a contract, the



Picerno reviews Commissioners' progress

Nick Picerno is proud of the Moore County Board of Commissioners

"We have accomplished every goal that we sat forth," Picerno told The Times, referring to a goal-setting retreat the Commissioners held in January.

"We sat down in January and we decided 'These are the four things we really want to accomplish.' And now you look back from September to January and we've done it. We've accomplished every one of them."

Picerno is the Chairman of the county's Board of Commissioners, but he is also its least experienced member, with not yet twelve months under his belt since his election. Commissioners are elected by a vote of the whole county, but only one Commissioner is drawn from each of five residency districts. Picerno, a resident of McLendon Hills, represents the county's southwestern district, which includes both Pinehurst and Seven Lakes.

The Times interviewed Picerno on Friday, September 11, to get his perspective on what progress the Board has made in meeting the goals it set nine months ago.

The Commissioners settled on four main goals during their January retreat:

- To hold down the tax rate.
- To improve the county's computer systems in order to avoid duplication of effort and improve service to taxpayers.
- To improve the county-owned water and sewer system, in particular by increasing the supply of water available to customers in Pinehurst and Seven Lakes.

 To move forward with a new county administration building, public safety complex, and jail.

"If you look at how we've done in these nine months, Picerno said, "every board member has worked extremely hard, brought to the table their conviction, and laid it out for the public. I appreciate that, because that is exactly what I think we should do."

"It's not been just one commissioner that has done it," Picerno adds. "It's the work of five people that this county elected to represent them."

Picerno then led The Times through a review of each of the Board's goals and what had been done towards accomplishing them.

"I want to make it clear that I can only speak for myself, as one Commissioner," he noted. "I can't speak for the other four. But I can tell you, from my point of view, how I went about looking at the issues."

Taxes

The Board's goal on taxes was to keep the tax rate low, and they exceeded that objective, actually lowering the property tax rate by 1.4 cents per hundred dollars of valuation, as well as cutting the Advanced Life Support levy by a half-cent.

The fact that the commissioners were able to reduce taxes in FY 2009-2010 Picerno attributed in large part to the proactive role that County Manager Cary McSwain played in holding the line on expenses in the last half of FY 2008-2009.

"If you go back to the retreat, the Commissioners pretty well conveyed to the Manager that we wanted to hold the line on taxes," Picerno said. "He implemented cost reduction, hiring freezes, and so on, that made it possible for us to look at cutting taxes when we looked at this year's budget."

Approaching the new budget, "my process was to ask a lot of questions," Picerno said. Noting that County Finance Director Lisa Hughes had prepared a very detailed briefing book on county finances, he said he worked his way through that resource, department by

department, flagging anything that concerned him.

"I reviewed the numbers in the county budget and the school budget," he explained. "I asked a lot of questions. The board of

Walk softly – and leave no trace! ference and that is teachers," Superintendent Dr. Susan Purser reported at the Monday, September 14 meeting of the Moore County Board of Education. "We looked at what we could trim on a daily basis because every penny saved was saving positions."

The \$57.9 million State Fund coupled with the \$28.7 million local Current Expense Fund represents ninety percent of the schools overall budget. In addition, Moore County Schools received \$12 million in Federal funding which includes nearly \$5 million in stimulus monies under a two year program.

"I am concerned what happens when the stimulus money goes away. We're going to be in serious trouble," said School Board Member Susan Black.

However both Purser and Chief Finance Officer Mike Griffin said that, overall, the school system is positioned well.

In June, the Moore County Board of Commissioners approved a flat budget request – maintaining last year's funding request; at the same time, Purser directed \$900,000 to classrooms from the central administration budget.

"The unintended byproduct [from budget cuts] was that the response from the community has been phenomenal," Purser said. "It's a tribute to our community. That's what Moore County is – a great place."

Ten-day Enrollment

12,280 students are enrolled for the 2009-2010 academic year in Moore County including 528 students at West End Elementary, 825 students at West Pine Middle, and 2,059 students at Pinecrest High School. Half of the enrollment is served by school bus transportation, with 136 buses covering 10,000 miles a day.

Other Business

In other business, the Board:

 Elected MCS Board Members Charles Lambert, Laura Kelly Lang, Dr. Lorna Clack, and Chair Kathy Farren as voting delegates for the North Carolina School Board Association annual conference.

Heard from Deputy Superintendent Dr. Larry Upchurch that Phase I projects of the Master Facilities Plan are currently under budget and expected to be complete by the end of this academic year.



Ordinance change would limit wireless towers

Thirteen areas in Moore County have been identified as having less than adequate wireless telecommunication access — including several rural pockets immediately northeast and northwest of the greater Seven Lakes community.

Reporting to the Planning Board on Thursday, September 10, wireless consultant George Condyles of The Atlantic Group of Companies recommended changes to the Zoning Ordinance to create Permitted Commercial Development Tower Areas [PCTDA] at these thirteen specified locations, strictly limiting locations of any new, freestanding wireless towers with a height up to 195'

Currently there are forty-three wireless structures in Moore County, each with a capacity for five carriers, plus there are six additional towers in adjacent counties that influence coverage.

According to Condyles, this existing infrastructure is capable

of meeting most future needs through a process termed colocation or the sharing of space on an existing structure. In addition to the thirteen locations identified as PCTDAs, 80' shorter towers – sometimes called mini-micro towers - would be allowed in all areas of the County

Alternate Member Harry Huberth argued that all new, free-standing structures regardless of height, both concealed and unconcealed, should require a Conditional Use Permit.

"An eighty foot pole —even if it is concealed — the neighbor is going to know it's there," Huberth said.

However, Chair Nancy Roy Fiorillo responded that permit applications could not be denied simply on an opinion about appearance.

"We can't take into account neighbors saying "I don't want that there" . . . I want to discourage people from coming to a Public Hearing [as required for a CUP] when they can't have any effect," said Fiorillo.

After discussion, the Board approved Member Kim Von-Canon's suggestion that would require wireless carrier to conduct a Community Meeting on appli-

cations for free-standing micro towers.

The proposed amendments to the Moore County Zoning Ordinance now move forward to the County Commissioners for final approval.

Parkwood rezoning deferred

A request by the Planning Department to rezone two tracts located in Seven Lakes West from Village Business to Gated Community-Seven Lakes was delayed to allow staff additional time to gather information. The .88 acre and .77 acre tracts are located on Parkwood Court and access is limited by the Westside gates. The request will be heard at the Thursday, November 5 meeting.

Other business

In other business, the Moore County Planning Board:

- Convened as the Moore County Watershed Review Board and approved a Special Non-Residential Intensity Allocation request by Paul Trudeau, increasing the maximum built upon area from 24% to 45% to allow for the construction of two additional mini-warehouse units on a 6.34 acre parcel located on US Hwy 1 near Vass.
- Deferred proposed amendments to the Planning Board By-laws regarding alternate members for additional discussion in November.

Gowan looks back on 90 years well spent

Reflecting on a lifetime well spent, Northsider James Gowan said he is most proud to have served with "some of the most brilliant people I ever knew," during his career in the U.S. Army.

As a young officer, Gowan and his family spent a total of 104 months of service living in occupied Japan, Okinawa, Korea, Thailand, and Austria, among

others. During this period, Gowan was honored to work under General Douglas MacArthur and General Frank S. Besson, Jr.

Born in Spartanburg County, South Carolina, Gowan went to work on a dairy farm at nine years of age. Over the years he was awarded numerous commendations and retired from the Armed Forces in 1965. He said he then tried to lead a normal, civilian life, but just never got the hang of it.

"I was always very happy in the service. I thought they did a lot of good things . . . I was in the brown shoe Army," Gowan recollected.

In 1993, he and his first wife Esther relocated to Whispering Pines and then decided to move closer to their twin daughters, Patrice and Denise, and became residents of Seven Lakes.

"He went from a buck private to a major, which is quite a feat," said daughter Pat. "He has led an interesting life. He is the anchor in our family."

Gowan and Esther were married for sixty-six years and have three children, including son Jim. Some months after Esther died, Gowan saw a man doing yardwork around the neighboring house. Thinking this must be his new neighbor, Gowan went over to introduce himself.

It turned out the stranger was Frank, the gardener, who was happy to introduce Gowan to his new neighbor, Patricia.

"We blame Frank," joked Patricia, now Gowan's wife. When they met, she had also been recently widowed, and the friendship between the neighbors quickly blossomed.

"There were sparks right away between the two of them," Pat said. "And they are very happy."

With Patricia by his side, Gowan's family grew once again to include three more adult children and their families.

On September 1, surrounded by his proud family, Jim Gowan celebrated his ninetieth birthday.

When asked what was the most important lesson he has learned over the years, with great humility Gowan responded, "That I don't know much."





Representative Boles graciously responded to many questions from the floor after he had made his comments.







Moyers to deliver 'Promise of Hope' lecture

An award-winning journalist with a history of personal addiction and recovery will bring his story to an upcoming Foundation of FirstHealth event.

The Promise of Hope Lecture featuring William Cope Moyers will be held Thursday, September 24, at Sandhills Community College. Registration will begin at 5 pm, and the program, titled "Unmask the Stigma: A Revealing Insight into Addiction," will follow from 5:30 to 7 pm in Owens Auditorium.

Now the vice president of Foundation Relations for Hazelden, a national nonprofit that helps people reclaim their lives from addiction, Moyers will use his personal experiences to discuss the power of addiction and the power of recovery. He has a compelling story to share.

"Mr. Moyers brings a deep understanding and strong personal commitment to recovery," says Jean Souweine, founding member of the Promise of Hope Lecture Series. "When we endowed the lecture series, my wife Mary Jane and I wanted to empower the Foundation of FirstHealth to bring expert, nationally renowned speakers to our community. It is an honor to have this author, who reaches thousands of people each year as he shares his personal experiences with the perils of addiction and the power of recovery."

Before joining Hazelden in 1996, Moyers had been a journalist for 15 years, working for CNN, Newsday and various other media outlets throughout the country. A 1981 journalism graduate of Washington and Lee University, he had a unique perspective on his profession as the son of Bill Moyers, a veteran commentator and Lyndon Johnson's presidential press

But addiction and recovery changed the direction of the junior Movers' life as he noted, as follows, in a commentary called "Voices for Recovery Muffled without Congressional Action, Presidential Support":

"Physically exhausted, drained emotionally and teetering on the edge of financial bankruptcy, I somehow made it out of a New York City crack house in 1989 and into a drug treatment center in Minnesota. After a decade of using and abusing cocaine, alcohol and other drugs, I was in trouble and needed professional help. Help is what I got. And ever since, I've learned that opportunity comes from adversity. Today I hold a job, pay taxes, raise a family, vote and obey the law."

Moyers found help at Hazelden, one of the largest not-for-profit alcohol and drug addiction treatment centers in the world. Hazelden's chief medical officer, Marvin D. Seppala, M.D., has this to say about Moyers: "William Cope Moyers is the nation's foremost voice for recovery from addiction. He uses his own story of recovery to educate and to provide a real sense of hope to anyone dealing with addiction."

The author of the bestselling memoir "Broken," Moyers has produced a journal and DVD set, titled "A New Day A New Life," designed specifically for those in early recovery. He has also appeared on "Larry King Live," "Today," "Good Morning America" and "Oprah."

Movers' work has been featured in the New York Times, Chicago Tribune, Los Angeles Times and Newsweek magazine. He also writes "Beyond Addiction," a nationally syndicated column on addiction and recovery-related issues for Creators Syndicate.

The Promise of Hope Series is made possible through an endowed fund supporting education for the community - providing hope and inspiration for those experiencing a terminal or chronic illness. In addition, the Behavioral CARE Fund of the Moore Regional Hospital Foundation provides support for patients and their families undergoing treatment and addiction therapies at FirstHealth Moore Regional Hospital. 

education, the superintendent, [MCS Finance Officer] Mike Griffin, were all very helpful, very forthcoming, and very truthful. I asked a lot of them. I might have been viewed as being harsh on them. But I was trying to get to an understanding of the numbers."

"The end result was that reducing taxes was one of our goals and we achieved it. Going forward, I hope we will continue to maintain that mindset. And the school board has the same posture. They look at every penny just like we do."

Computer systems

Turning to the goal of upgrading the county's computer infrastructure, Picerno noted that he had just the day before signed a contract between the county and Tyler Technologies for a new system that will integrate the software systems used across county departments, including Tax, Finance, Information Technology, Human Resources, and Planning.

"Now we'll have all the departments on the same platform," Picerno told The Times. Our departments will be working with software that can talk with each other, instead of having multiple independent systems." The result will be less rekeying of data and more efficient county operations.

A variety of department heads served on the committee that

assessed the county's computer needs and evaluated various options in a process that stretched over four years, Picerno told *The Times*.

But when it came to holding down the price of the new system, Picerno praised the negotiating skills of Commissioner Tim Lea. Noting that he had first looked at the proposal from Tyler as a member of the Government Efficiency Advisory Board, before he was elected to the Board of Commissioners, Picerno said the pricetag at that time was over \$2 million. Additional work and negotiations got the price down to just under \$2 million when it was presented to the Commissioners earlier this year. The final contract price was just over \$1.5 million.

"By due diligence, working with the company, were able to save taxpayers in excess of \$400,000," Picerno said. "And we met a goal."

"And I give Tim Lea's negoti-

ating skills a lot of the credit for that."

Picerno said the integrated system would continue to save county taxpayers money going forward — as well as improving customer service.

Water

"We have done a very poor job of telling people in the county what we have done on water — of getting the information out," Picerno said, turning to the goal of improving the county's public works infrastructure.

"Very few people know that we have 1.1 million gallons per day more now than we did on January 1," he explained, referring to a connector that carries water purchased from Harnett County through the East Moore Water District to Pinehurst and Seven Lakes.

"In the last year we have added over a million gallons to our water supply — that's the equivalent of eight wells being drilled in Pinehurst — and nobody knows about it."

Picerno said the county water system can currently supply 5.6 million gallons of water per day, and noted that the highest single-day water usage ever recorded by Public Works was 4.2 million gallons per day.

"So right now, we have excess capacity."

But, with a firm memory of water shortages that the county has suffered in the past, a number of projects are in the works to increase water production even further, Picerno told *The Times*:

 The county is waiting for a Certificate of Appropriateness from Pinehurst Village in order to complete construction of a wellhouse on Pinehurst #2 that will blend water from two wells and add another 453,000 gallons per day.

- A rehabilitation of Well #10 has added 72,000 gallons per day to supplies.
- The county is negotiating with both the Town of Robbins and Montgomery County on options for bringing additional water to southern Moore County.

On the wastewater front, the county is moving ahead with a sewer lift station project to correct a serious system deficiency around Lake Pinehurst.

Picerno said Public Utilities and the county's GIS department are working on a project that will provide a detailed map of current capacity and current

"We hope to share that with the public at some point in the future" he added.

"It's not like Moore County Public Utilities hasn't been doing anything," Picerno said. There are a whole variety of things out there that we are working on We are doing planning. We are doing due diligence. The McGill Study was not thrown in a back corner. All these things are in place and being worked on."

Buildings

Where to put the county's new administration building, public safety complex, and jail have been one of the most contentious issues the Commissioners have faced during the past nine months.

When it came to the administration building, Picerno found himself with two Commissioners committed to a downtown Carthage location on the Grimm property, and two urging consideration of a site on countyowned land near the Carriage Oaks Shopping Center.

"I had to sort of delay the process," Picerno explained. "I had not seen or considered the other piece of property [Carriage Oaks] as an alternative. I felt it was my duty to take a look

Picerno told The Times he had large format maps of the alternative locations produced by the GIS department, and then talked with a range of professionals about the pros and cons of the two sites. In the end, he felt Carriage Oaks posed too many problems for the Administration building, while the downtown Carthage location "brings everything downtown. Everything is centrally located."

Noting the recent protests by some Carthage residents over the downtown location of the new jail, Picerno noted that his mother lives just a few blocks over on Saunders Street.

"I just don't ever see a 700-bed detention center in Carthage," Picerno told The Times. "In the entire history of the county, we've gotten to 130 inmates. I don't see us getting to 700 in the next 50 years."

A new modern detention center, with state-of-the art equipment, will be safer than the existing facility, he argued. He noted that the new jail will be sandwiched between the old jail and the public safety building, giving inmates little option if they decide to try an escape.

Addressing the split votes the Board has had on the issue of where to place the buildings, Picerno told The Times, "We may not be united on where to put them. But it's not because we aren't united on needing the infrastructure. Good people can disagree."

"The bottom line is, each of the commissioners was involved in the process. They did their work, they brought their vision to the meetings. Only time will tell which vision was right."

"After I added everything up, I voted my conviction based on what I told the voters I was going to do when I ran for the Board. The voters can decide, if the majority don't agree with the decisions we made, then the voters have the power to say 'We think you were wrong."

Going forward

"I'm real proud of this board," Picerno told *The Times*, "the way they have helped me become one of the members of the Board and do an effective job.'

"And we have been effective --the way we worked with the schools, with the architects, with the software company. I am really excited that we have been able to accomplish these things. I am excited that I was able to be one of the people that helped get

"What we have," Picerno said, "is a Board of compassionate people who do the best they

Referring to press coverage about split votes on various issues, he added, "I don't believe we have a split Board. We are all just doing what the voters asked us to do: bringing our own vision, our own convictions, and doing the best we can for the people of Moore County."

LRA aims to help protect lake quality

Dear Editor:

We wish to repeat our announcement of 7/10/2009 that we are now able to "in-house" test the waters in our several lakes for bacterial contamination. While all freshwater lakes harbor coliform bacteria, they may also host the more dangerous subset, E.Coli, which if present in large enough quantities may cause gastro-intestinal illness, eye, ear, nose and throat infections, respiratory ailments and skin complaints.

While we do not profess to be accredited lab technicians, the test we perform using Coliplate™, a defined substrate technique, is designed for public use and is widely recognized

as being fast, user friendly and accurate. It has become increasingly popular with researchers, universities, and government agencies at all levels and has been approved by the American Public Health Association (APHA), the Environmental Protection Agency (EPA), and Environment Canada. Manufactured by Bluewater Biosciences in Toronto, Ontario, it is widely used in the provinces by remote lakeside cottage associations where analytical laboratories are few, far between and inaccessible.

In two short months, we have learned a great deal; and, over time, we will gain a far more complete understanding of our

lakeshore waters and how bacterial contamination may be influenced by changes in climate, water temperature, depth and circulation, wind and wave action. cloud vs. sun, time of day, geese and other water fowl, unleashed dogs and other animals, bathing load, watershed run-off, ageing septic systems and doubtless other factors not yet thought of. The best way to understand and make use of this knowledge is through frequent testing particularly during the summer months, by a group of willing volunteers.

The Lakeshore Residents Association (LRA) is just such a group. We wish to thank those of you in Seven Lakes North & West as well as in McLendon

Hills who have expressed an interest in preserving the pristine quality of our freshwater lakes, our greatest assets, and who have offered to assist from time to time in monitoring these waters, gathering samples either off their own docks or at public swimming areas, and quantifying the results after the samples have been incubated.

The information gained to date is interesting and may be summarized as follows: Of the fifty samples taken from our various lakes since July 8th. the geometric mean (average) for Total Coliform was 434 cfu/100ml and for the more worrisome E.Coli. 11.4 cfu /100ml. While five of the fifty samples exceeded our own goal of 126 cfu/100ml, only three exceeded the single EPA recreational water guideline for E.Coli

of 235 cfu/100ml. Even more encouraging is the knowledge that in every instance, subsequent re-tests were found to be within normal limits. E.Coli can simply come and go overnight.

The good news is that we are now able to order coliplates in larger quantities and thus reduce our costs. We have been able to reduce the cost of each test to \$10.00. We believe you will agree that it is money very well spent!

Board unanimously approved the contract with Underwood.

Vaughn told *The Times* on Wednesday that two of the three new wells will replace existing wells.

Well 6A will replace Pinehurst Well 6, near the Bretton Woods townhome development. That well has been contaminated with MTBE, a gasoline additive. Both Well 6 and an irrigation well in Bretton Woods will be capped. If a test well proves productive and contaminant-free, a new production well will be drilled roughly twenty feet from existing well 6.

Well 3A will replace Pinehurst Well 3 at the Pinehurst Harness track, an older well whose casing corroded, muddying the water. Because of the location of this well, the county will need a Certificate of Appropriateness from the Village's Historic Preservation Committee approving the design of the well house.

The third well is a new one — number 23 in Pinehurst — that will be located on the former site of the Gun Club-Village Acres swimming pool on Spring

Lake Drive, property owned by Pinehurst, Inc.

Other Business

In other business during their September 8 meeting, the Commissioners:

- · Heard from Carthage resident Tom Daniel, who said he represented a group of perhaps 200 South Carthage landowners concerned about the impact that a proposed Highway 24/27 bypass south of town might have on their properties. Daniel said he was trying to set up a community meeting that would ideally include the affected landowners, members of the Carthage Town Council, and Commissioners, with the goal of understanding what position the county and town are taking on the proposed southern bypass.
- Issued calls to public hearing for September 21 on technical revision to the county's zoning ordinance, as well as an amendment to the zoning map that will make it better reflect the actual boundaries of the TH Blue mulch busi-

ness in Eagle Springs.

- Issued a call to public hearing for September 21 on a rezoning request in the Vass area that will accommodate a new business that will be training dogs for use by the military. Planning Director Raczkowski told Commissioners that, because the request is linked to an economic development opportunity, the Planning Board will hold a special meeting the morning of September 21 to consider the request.
- Approved the use of \$4,166 in school bond funds by the Board of Education to purchase one-tenth acre of land in the Westmoore Community as the site of a water pump station, with the proviso that Public Works will work with the school system to evaluate other water system options that might be more appropriate than the proposed pump
- Approved a contract for a \$717,000 Home and Community Care Block Grant that Aging Services Director Terri Protts explained is the primary source of funding for the county's transportation,

- in-home aid, and meal programs for seniors.
- Issued a proclamation declaring the county's intention to support the goal of achieving a full count in the upcoming 2010 census.
- Authorized the Community Development staff to apply for an \$8,000 grant that could be used for lead abatement in substandard housing, supplementing the county's scattered site housing program.
- Approved a contract with Max Paving for the expenditure of up to \$80,000 for street repairs required after Public Works road cuts and other activities.
- Authorized the release of an easement the county has but

does not plan to use across the property of a Pinehurst landowner.

- Waived landfill fees for the disposal of burned debris from the West End Boy Scout Lodge.
- Appointed the three members of the Human Resources Appeals Committee, along with a representative of the County Attorney's Office, to a Compensation Review Committee that is supposed to undertake a comprehensive analysis of the county's compensation polices and have that ready for review by the Commissioners by November 1

CAS contract will be renewed.

"I want to know firm numbers of what they will request next year so we can plug that into the budget."

Herdrich said an evaluation of CAS would be conducted during Executive Session immediately following the Work Session and that, if approved to move forward, CAS would send their request next week.

Hiking Trail?

Director John Goodman presented a rough proposal for a community Hiking Trail extending from around the dam, along the perimeter horse trail at Morganwood, to the old airport prop-

"Most communities of our quality have trail systems that go through the community. This is an amenity that could be used for many purposes," Goodman said.

As proposed, the project would require voluntary assistance and, if possible, purchase of land at a reasonable price or acquiring easements at different segments.

"There would be an added advantage of security, aesthetics, and a buffer - we lost a lot of our buffers in bankruptcies," Goodman said.

During Public Comment, Roger Brooke spoke in favor of the project.

"Hiking trails and the beauty of roadsides are critical to the aesthetics of a community, for land value, and as amenities. We need to reinforce that those things are important," said Brooke. **Lake Auman Dam**

Comprehensive drawings, the Emergency Action Plan [EAP], and a letter from engineer Dan Marks were submitted to the State, reported Herdrich. Marks will continue to evaluate dam seepage for the next six to eight months and the final decision of whether or not to reopen the dam road will be subject to the State's certifications and review of Marks final report for the remediation.

Herdrich reported grass on the dam face will be moved after September 15 - with a new landscape contractor who offered a reduced rate. In addition, leftover rip rap material from the weighted filter project will be installed at a few locations.

Architectural Review

Director Adam Wimberly said ARC will make a recommendation to the Board with new standards for outdoor decorative structures such as pergolas, gazebos, arches, and trellises.

Wimberly also reported ARC members have discussed the wisdom of having the committee chaired by a potentially inexperienced member of the Board.

"There is a nine month learning curve," Wimberly said.

Director John Hoffmann opposed such a change, arguing that all committees should be chaired by Directors because they act on behalf of and carry the legal authority of the Board.

Director John Goodman also expressed concern, "I do not care for the idea of long term chairmanship without an election for something as powerful as ARC."

Wimberly countered that the six hour regular meetings of the SLWLA demonstrated that the Board was taking on more than they should.

"We have got to look at putting more trust in our committees," said Wimberly. "By having meetings going on as long as they do is saying to anyone gainfully employed, "you can't participate."

Infrastructure

Goodman reported that over time silt and soil wash away from road shoulders leaving only sand - which will not support the

"We do not have a program to address erosion," said Goodman. "My question is who is responsible?"

He said the right of way extends thirty feet from road center with an additional five foot utility easement on Association property and a fifteen foot utility easement extending on private property.

"Some of the erosion is occurring from the road to lot other from lot owners to the roadway: it gets complicated," Goodman said. "We need to comprehensively look for a solution."

Goodman proposed selected ten to twelve targeted test areas and hiring landscape contractors to manage one or two each. Sand would be removed, the soil amended, and then seeded or landscaped. Long term costs and maintenance required for each could then be evaluated for the best solution.

Safety & Security

Due to cost overruns in the guard budget, Hoffmannn reported that security patrols had been scaled back to two days a week. To date, the Association has spent \$2,040 to employ off-duty Moore County Sheriff's Deputies.

Hoffmann said he could employ SFI guards to provide a roving patrol at half the cost, with the Association providing the truck and fuel, and that he was comfortable that the background checks and personnel of SFI were adequate.

Goodman and Wimberly argued that security employees and vehicles would not command the same level of respect or have the same high quality training and certification as the Sheriff's office.

Also during the Security report, Hoffmann said that door-to-door commercial solicitation is prohibited within the community.

Silberhorn said regulations (See "Westside," p. 27)

could not restrict a resident from choosing to solicit neighbors for charitable or political purposes.

Goodman suggested that individual homeowners should have the opportunity to place themselves on a "Do Not Call" list that would be held at the office. Frost responded that such a list was possible and could be maintained.

Long Range Planning

President Ron Shepard said the Long Range Planning LRP] Committee was preparing a survey that would not be mailed but rather distributed at the office, electronically from the website, and through the newsletter and The Times.

"We are trying to get an updated look at the future that people would like to see here at Seven Lakes West and then get that incorporated into long range planning," Shepard said.

Wimberly said such a survey was long overdue but questioned the open-ended response format as proposed.

"If you ask an opinion – rather than analytically you have to be tactical: what do you want and what are you willing to do to make it happen?" Wimberly asked. "What is it worth to you...to have a walking trail, back gate security, new roads?"

Shepard said the open-ended question would provide opportunities for new ideas and allows residents to express themselves.

"Part of this asks how would like us to look in a few years. You have to have projects first then you can evaluate cost," said Shepard.

Goodman felt compromise was required, with Long Range Planning outlining a plan while information gathering and analysis was done concurrently.

Kirst agreed and said she strongly encouraged the Board to work in a coordinated and constructive manner with LRP. She also praised the Lake Auman Master Planning document that was drafted several years ago.

Hoffmann agreed, calling the plan, "the most important document we own."

However Director Karen Milli-

gan argued that any document, no matter the quality, was just paper unless the Board knows the residents are willing to pay for the plans.

After discussion, Wimberly and Shepard agreed to jointly revise the survey and explanation letter.

good enough' malaise of Seven Lakes," Zielsdorf said. "Appearance can add property value. I understand being fiscally conservative, but you can pinch a penny and waste dollars."

Assuming a seven percent interest rate, Zielsdorf said payments on a \$500,000 loan would run approximately \$72,000 a year -- less than the anticipated annual reserve income.

Within the project, priority will be given to several areas that need additional attention or repairs, including Dogwood Lane. Of specific concern is whether removal of the mature pines along this main entrance road will be required because of root damage to the roadbed. After discussion, the Board agreed that an expert opinion was needed and asked Assistant Community Manager Chad Beane to contact Craven Hudson, the Director of the Moore County Extension Office and also, ironically, a resident of Dogwood Lane.

New Community Management Search

Information on the three community management companies currently under consideration by the Board will be available in the SLLA office by Friday, announced Zielsdorf.

"Keep in mind that these three companies compete with each other and we do not want to give out proprietary information ... cost quotes will not be included." Zielsdorf said

Resumes and the names of individual candidates will remain confidential.

Zielsdorf said the September 30 SLLA Open Meeting will include a special public comment segment to allow residents to provide input on the search for a community manager or management company.

However, he made clear that the Board of Directors will not call for a vote of the landowners on the question of whether to hire an individual or company for future management.

"In a vote, only thirty percent participate, which is not a big enough cross-section," he argued. "The residents elect the Board, who represent the community. If residents really feel strongly to vote, there is a way, and that is to become a municipality."

Zielsdorf said that taking such a step is not on his agenda but would be for future boards and future residents to decide.

Back Gate Security

Community Manager Dalton Fulcher said the 'suspicious person' reported entering and exiting the fire safety gate at Firetree Lane and Holly Grove School Road was determined to be the son of a resident. He had been using the gate as a shortcut from his own residence which is located outside of Seven Lakes.

Fulcher said keys to the gate

are maintained by the rescue squad in case of an emergency, otherwise the gate remains locked at all times.

Droppers recommended a less scripted -- and less predictable -- scheduling of Roving Patrol would improve security.

In related discussion, Fulcher also said that residents may no longer call in an Open Gate request. Guest names must be called in to the gatehouse. Exceptions can be made with office preapproval if a resident is expecting a large group or has a special circumstance, such as a death in the family.

Greater Seven Lakes Community Council

Zielsdorf reported that the Greater Seven Lakes Community Council [GSLCC] met with three representatives of the Moore County Sheriff's Office on Tuesday, September 1.

"We got their attention . . . this is one example of our communities are willing to work together that we can pool our votes and get their attention," Zielsdorf said

The eight-member GSLCC

includes Zielsdorf and the presidents of the Seven Lakes West Landowners Association [SLWLA], the McLendon Hills property owners association, the Seven Lakes Business Guild, and an alternate member from each entity.

"Sheriff Lane Carter said we are large enough to be a municipality and have our own police force," Zielsdorf reported. "He said that, over the last few years, they have stepped up patrols in this end of the County and will continue as long as there is funding."

He advised that there are basically two ways to increase law enforcement coverage: hire an off-duty Sheriff's Deputy at \$30 an hour, or pool resources and collectively hire one or two officers to patrol the Greater Seven Lakes area.

Zielsdorf estimated a fully loaded salary with benefits would run \$61,000 which does not include the additional cost of equipment and a vehicle.

"This is not particularly cheap; but, if you split it up, the costs are not that bad," Zielsdorf said, noting that the majority of the costs would be borne between SLLA and SLWLA, since they are the largest of the four entities.

"If we spring for equipment, I would also suggest we look at hiring two officers to share the vehicle. It would be more cost effective," Zielsdord said.

In addition, Roving Patrol would still be necessary, explained Zielsdorf, since the Sheriff's Office would not enforce community rules and regulations.

Sequoia Point Facilities

The restrooms at Sequoia Point have been vandalized on several occasions over the past few years, prompting Zielsdorf and Kindsvatter to recommend locking the facilities after dark.

Fulcher strongly opposed the suggestion, stating such action would penalize many for the sake of a few.

"The vandalism isn't much. The amount of vandalism in Seven Lakes is so, so low compared to other communities," Fulcher argued. "We have people that walk and use those restrooms. We should use the facil-(See "SLLA Work Session," p. 29)

to east along the entire property. However the project closely follows the recommendations of the Small Planning Area A plan, which calls for low density development, retail and commercial space along highway corridors, and large amounts of open space.

The owner and developer is Bob Hanson, who is also spearheading the Dormie Club project. On Wednesday, September 16, Hanson and representatives from Hobbs, Upchurch Associates met with the community during a public meeting at West Pine Middle School.

The Master Plan includes a rezoning request for 1,623 acres to Planned Unit Development-Hamlet [PUD-H] with a combined maximum density of 890 total units including hotel rooms and private residences. Pine Forest is broken into two individual communities that will share amenities, design characteristics, and infrastructure. The first residential community includes the retail area and resort hotel with an eighteen and nine-hole golf courses. The second residential area is located north of Nick's Creek and features a gated community and another Championship eighteen hole golf course.

The resort includes a maximum of 300 hotel rooms, and will feature a spa, conference center, and a fitness center. In addition, each golf course will have its own clubhouse. The retail and office center is proposed at NC Highway 211 just north of Archie Road and will offer a maximum of 120,000 square feet.

Water for the project will come from Montgomery County based on an agreement between Moore and Montgomery County. The developer has agreed to construct a connection line and anticipates an agreement with Moore County Public Works.

All wastewater will be treated on-site at a facility built to Moore County standards. The plant will take 350,000 to 500,000 gallons per day from the Moore County wastewater system for irrigation of the golf courses, lawns, and common areas within the Pine Forest Development and the Dormie Club, which is located across NC Highway 73.

The wastewater plant will be located on a new public road that will run along the eastern boundary of the property and connect Archie Road [West Pine Middle] with NC Highway 73.

This artery will alleviate congestion along NC Highway 211 while providing interior access to the resort and retail area. In addition, the developer is working with Moore County Schools to provide access to the new road from West Pine Elementary, a new school that is under construction immediately behind and adjacent to West Pine Middle.

The overall proposed density for the project is .54 units per acre – roughly one home for every two acres – and includes fifty percent open space, which significantly exceeds the PUD-H requirement. As presented, there will be no wetland impact, as no residential lots are located on wetlands, and all three crossings of Nick's Creek will be bridged with the golf courses serving as natural buffers.


