

## Foxfire Village annexes more of Grande Pines

Several lots within the Grande Pines gated equestrian community were annexed into Foxfire Village by the Village Council during their Tuesday, September 9 regular meeting.

The village requires that property owners have water lines in place before annexation can be granted. At the Village's request, developer Pete Mace included in his annexation request all of the

Grande Pines lots that he hopes will ultimately be annexed. Three of those tracts do not yet have water lines in place.

Councilwoman Leslie Frusco asked that those three not be included in the vote.

"I would like to remove those three pieces of property before we do the annexation," Frusco said. After removing those lots from the motions, the council voted unanimously in favor of the annexation.

Mace thanked the Council. "Five years ago, we put in waterlines and paved the road," he said. "We sold a

couple of lots. Now we are getting a lot of activity. It's going to grow. We are getting activity, and it will be a good tax base for the Village."

The Council also discussed rezoning the annexed properties. The land is zoned Rural Agriculture [RA], a zoning designation that is not permitted within the village limits, but only within the surrounding Extraterritorial Jurisdiction [ETJ].

"We will need to get all of that property rezoned," Frusco said. "We now need to refer this back to the Planning (See "Foxfire," p. 27)

## Speeding is the focus at Westside town hall meeting

Speeding on the streets of Seven Lakes West is a perennial problem — and a reliable source of complaints from residents.

So, it was not surprise when speeding dominated the discussion at a town hall

meeting on safety and security convened by the Seven Lakes West Landowners Association [SLWLA] Board of Directors on Wednesday, September 10.

Former SLWLA President Mick Herdrich chaired the meeting. He asked members to not only express their security and safety concerns, but, "most importantly we would like your ideas of how

we might address these issues."

Seven Lakes West's "ring road," Longleaf Drive, is seven miles long, with a speed limit of 35 miles per hour. It is thought to be the only road in a local gated community with such a high speed limit.

"The problem is the perception that Longleaf is a commuting road," Herdrich said.

"It's the main drag to go to work, take the kids to school, and people don't think of it as a side road. We can't drop the speed limit to 25 miles per hour. It's a very complex problem that we have talked about over and over, and no one has come up with great solution yet."

"I moved here to get away from Fayetteville," said one SLWLA member who works in Special Forces at Fort Bragg and lives on Longleaf.

## Teachers get raises in new MCS budget

Two months into the new fiscal year, the Moore County School board has approved the district's budget.

The hold-up has not been the school board, the county Board of Commissioners or Moore County Schools [MCS] staff, but rather the state legislature, which only recently approved the state's FY2015 budget.

Until the state budget is approved by the General Assembly and signed by the Governor, MCS cannot finalize its budget.

MCS Director of Budget Mike Griffin told the school board that the FY2015 budget includes both positives and reason for concern.

### State funding up

Chief among the positives was much higher than expected funding from the state, most of which went (See "MCS," p. 24)

# SLLA Board keeps boat length limits intact

A proposal to increase the size of boats used on the lakes of Seven Lakes North failed to win sufficient support from Seven Lakes Landowners Association [SLLA] board members during their Monday, September 8 Work Session.

But a proliferation of larger boats on Lake Sequoia means the issue is probably not going away.

During the meeting, George Temple was asked to remind the board of the process that led to the current length limits, approved in 2007. Currently, the maximum boat lengths are 17 feet for a ski boat and 23 feet for other power boats.

In 2007, the newly formed Lakes and Dam Committee spent weeks researching boat length, Temple said.

"It was not arbitrary," said Temple, who served on that committee at the time.

Temple explained that the Lakes and Dam Committee was formed in 2007. Former Director Ed Nuti was in the process of updating the SLLA rules and regulations. He asked Lakes and Dams to rewrite the boats rules.

"We formed a subcommittee made up of myself, George Stahl, and JoAn Moses to make a draft for Lakes and Dams," Temple recalled. "At that time the boat length limit was 19 feet.

"We had received an email

that there were at least two 20 foot boats and several in the 21 to 22 foot range. We didn't know precisely; but we said, 'If we went to 23 foot, would that be any harm?' We all agreed that was kind of the cut off for ski boats, open boats, and heavy cabin boats."

"We debated at length over 22 or 23 feet. We all agreed that nothing over 23 should be allowed."

"When you get heavy boats they throw humongous wakes, wash bulkheads out, and are real hard on boats tied to docks."

"Boats with cabins tend to have marine head toilets that pump into the lake and we didn't need that in our lakes."

"We agreed to increase the boat length from 19 to 23 feet."

"We didn't feel like we could have a smaller length and throw off all the other boats already out here."

## The wake's the thing

"Why are there no restrictions on sail boats?" SLLA Manager Ray Sohl asked.

Temple explained that, at that time, there was 26 foot sailboat on the lake.

"It didn't throw any wakes and wasn't a problem," Temple said.

Pontoon boats also throw little wake. Boats manufacturer and the state both determine boat length by the deck, not the overall length of the boat, Temple explained.

"When you get your registration from the state, it is

determined by deck length," Don Fentzlauff agreed. "It doesn't include outboard motors or anything else that protrudes."

"Last year, I spent \$800 on my bulkhead," member

Greg Lishawa said. "We have boats that can go on the intercostal and ocean. We have that big of boats with that big an engine."

"It used to be nice. It was fun on the lakes and very

quiet. Now we just keep getting bigger and bigger boats."

"The lakes' sizes are still the same," Director Sandy Sackman added.

# STARS Charter School eyes Academy Heights

Moore County Schools wants to get rid of it. Taylortown wants it but can't afford it.

Moore County doesn't want to buy with taxpayer dollars what it built with taxpayer dollars. And now, the Stars Charter School might want to lease it.

"It" is the building that once housed Academy Heights Elementary School, which closed in 2009 as the recession took hold and education funding took a hit.

During their Monday, September 8 regular meeting, the School Board unanimously approved a resolution declaring the property "surplus" and offering the Board of Commissioners the right of first refusal to purchase the property at "fair market value." The county has that right under state law.

During the Commissioners' Tuesday, September 16 regular meeting, that board formally declined to purchase the property, opening the way for the School Board to sell the property to another party.

During the public comment portion of the Commissioners' meeting, Wesley Graner, the principal of the Sandhills Theatre Arts Renaissance School [STARS], a charter school in Vass told the commissioners that his board was interested in "being part of the discussion" about Academy Heights.

## A Stars high school

Graner told *The Times* following the meeting that he, his board of directors, as well as a contractor and architect, have visited Academy Heights a number of times, evaluating its potential as a facility for a charter high school. Stars currently serves elementary and middle school students.

"Our parents want us to look toward a high school," Graner said. "We know it is something they want."

"I can't predict that this is the perfect site for us," he

added. "But, we should have the opportunity to discuss the site, which is why I spoke at the Commissioners' meeting."

"I don't feel like we have enough information to determine that yet. We haven't been able to sit down with the appropriate people. We want to be part of the dialogue about that site."

Graner told the commissioners that he had been in contact with Moore County Schools [MCS] about that interest over the past "three or four weeks," but had been

unable to arrange a face-to-face meeting.

## New state law aids charters

He acquainted the Commissioners with a portion of NC Session Law 2013-355, which requires that local school districts lease unused school properties to charter schools, unless that is "not economically or practically feasible."

State Senator Jerry Tillman, who represents Moore County in the General Assembly, was a primary sponsor of that law. If a charter school and

the local board of education are unable to reach an agreement about a lease, Graner noted, the final decision rests with the county board of commissioners.

Graner told *The Times* that he didn't yet have enough information to know whether STARS would be interested in leasing or purchasing Academy Heights.

After the meeting, MCS Superintendent Robert Grimesey told *The Times* that the School Board had made

clear, in its resolution, "that it wants to rid itself of the property."

"When you are leasing a property, you are still owning it," Grimesey said. "and when you own it, you still own responsibility for it."

"There's nothing to stop any entity, including STARS Charter School from participating in a competitive bidding process on the property," he said, adding that "STARS did not indicate an interest

# Compounding provides customized medications

Your pain medication puts you to sleep.

Those hormone pills haven't cured your hot flashes.

Your three-year-old hates the taste of her medicine — and your cat's not crazy about her pills, either.

Those medication challenges, and a host of others, are why the Seven Lakes Prescription Shoppe has invested in a new compounding lab.

"Compounding is where we customize medications for individuals and for animals," explained Pharmacist and Prescription Shoppe owner Rob Barrett.

"We are one of three compounding pharmacies in Moore County," Barrett said. "It's definitely not very common."

Better tasting medicine

A compounding lab can customize the dosage, the flavor, the form, and the inactive ingredients in a medica-

tion to meet the needs of the patient.

"If there's a medicine that [someone] needs that is not available in a pediatric dose, we can customize it," Certified Pharmacy Technician Jenn Demarest explained.

She continued, "We can

constantly change the doses and it doesn't have to be 'You're going from a 10 milligram. Well the next step up is a 20 milligram.' No, I can make it an 11, an 11.5, a 12 . . . It's just so specific."

Flavors can also be added

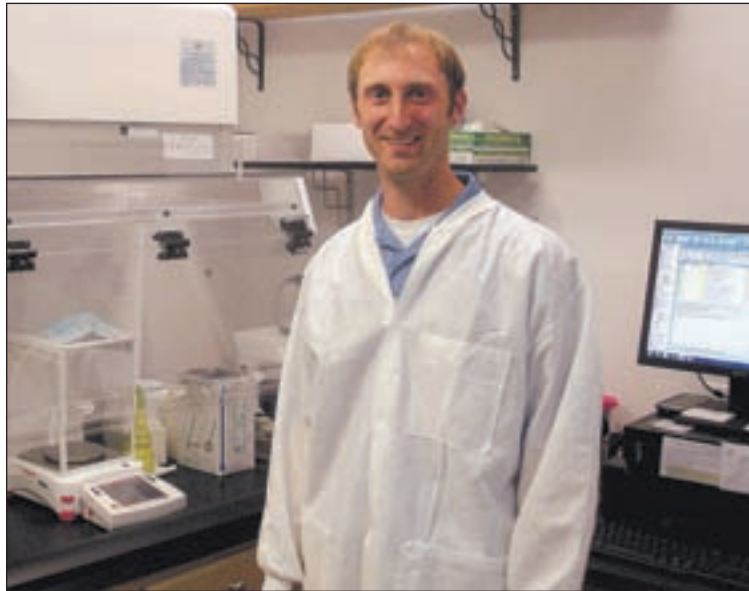
to make taking medication less of a hassle, especially for pets and children. Unique flavors for pets include peanut butter, salmon, and fish chowder.

"This way, I can put [the medicine] in a liquid and just squirt it into the dog food, and it tastes similar to the dog food," Demarest said. "There's no way of eating around it, and they're still getting their medicine."

"We had a lady who was looking for a chemo drug for

her dog," Barrett said, "and, I mean, that dog was really about to die in the next day or so. And so this chemo drug, if we were to purchase it from the manufacturer, it would have ended up costing her about \$500-\$600 for her to buy it. So I asked Jen, 'What if we just made this into a liquid for her?' It ended up costing her \$90. It significantly saved her money and the dog's life."

food, sealed packages, and filled food boxes. The packaged meals consisted of twenty-one vitamins, soy, and rice, costing about twenty-five cents per meal. Each package is designed to provide a meal for six people, and each Stop Hunger now box holds thirty-six packages.

when nearly 300 showed up to help.

Among the volunteers were American Heritage Girls, Boy Scouts, church members, and community members. Volunteers were served breakfast, and the Back Porch Band provided entertainment as everyone worked.

event.

"It's great to see churches and people in the community working together to stop hunger now," he said. "Especially little children . . . getting involved and doing right things. It's a joy to see different faith people working

together for a good cause — that is to feed the hungry throughout the nation and throughout the world."

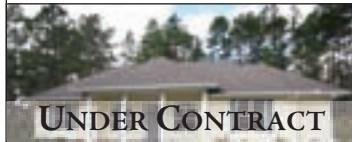

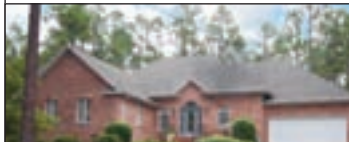

# County property revaluation gets underway

All of Moore County's real estate must be revalued in 2015 for property tax assessments. During their regular Tuesday, September 16 meeting, the Moore County Board of Commissioners took the first step in the revaluation process, calling an October 7 public hearing on a "schedule of values," presented by Interim Tax Administrator John Edmondson.

Edmondson explained that the schedule does not list the value of each property in the county — that happens in a later state of the revaluation process. Instead, the schedule assigns values to the various characteristics that determine a property's worth: whether it includes a home or is agricultural land, whether it is lakefront or golf front, how the property is zoned, whether it produces income, and so on.

The document is available for public inspection at the tax department's customer service area in the Historic Courthouse in Carthage. Citizens can review the document and recommend changes during the October 7 public hearing.

The adoption of the schedule by the Commissioners — likely during their October 21 meeting — triggers a

month-long waiting period during which citizens may take exception with the schedule and appeal to the NC Property Tax Commission.

Once the schedule is complete, the tax assessor's office will use it to assign a value to every property in the county.

## Simplifying state school funding

Also during their Tuesday, September 16 regular meeting, the Board of Commissioners approved a resolution aimed at simplifying the way in which the State of North Carolina provides funding to local school districts.

Money from the state comes in dozens of streams associated with specific objectives, limiting the local district's flexibility in using those funds.

The resolution asks that fifteen categories dealing with support services — including central office administration, non-instructional support personnel, and teacher assistants — be consolidated into a single funding stream. And it calls for the consolidation of several other funding categories.

The resolution calls on the NC Association of County Commissioners [NCACC] to include the requested consolidation among its legislative goals for 2015.

"This is real personal with

me," said Commissioner Nick Picerno, who is the county's delegate to the NCACC and serves on the association's finance and education steering

committees. "It [state funding] has gotten really wacky."

"We felt like we have a chance to go to the General

Assembly and maybe some common sense would take hold," he said.

# Schools, County working together on facilities

Moore County's School Board and Board of Commissioners

have taken their first steps toward crafting a joint plan for financing new and expanded schools.

The School Board has developed a \$111 million list of projects that includes the expansion of both Union Pines and Pinecrest High School, the construction of a new concept high school, three new elementary schools, a new middle school, and expansion and upgrades to other schools.

In a joint committee meeting on Wednesday, September 9, School Board members Ben Cameron and Bruce Cunningham presented Commissioners Nick Picerno and Randy Saunders with that list, so that the county's finance team could figure how how — and how quickly — the county can pay for the projects. The elected officials were accompanied by their respective executives and finance staff members.

"Let us work with how this fits into what we have, where we are going and how we can knock these off," Saunders said of the project list.

"We know that you have needs," Picerno said. "We feel like the tax burden is at the maximum, but if we can understand what your priorities are, maybe we could pull this off with the very minimum of borrowing. Borrowing adds cost, and that cost buys you nothing but time."

The county has substantial capital reserves that it can dedicate to school construction, as well as the ability to borrow at interest rates lower than those available for the taxpayer-approved general obligation bonds that are normally used to finance school construction.

"We are very much in agreement with you where the taxpayers are concerned," Cameron said. "We are willing to work on whatever way is

going to be the best deal for the taxpayers."

"The key is conversations," Picerno said. "You have to know where we are going, and we have to know where you are going — so that we

can minimize impact on the taxpayer."

"It is the best economic driver for Moore County going forward," he added. "We are trying to have the best schools, the best law enforce-

ment, and the least regulations. We want to make Moore County the place to come."

Following the September 9 joint committee meeting, County Manager Wayne Vest

and his finance team worked through the School Board's facilities plan, along with the county's financial consultant.

The Commissioners have scheduled a work session to

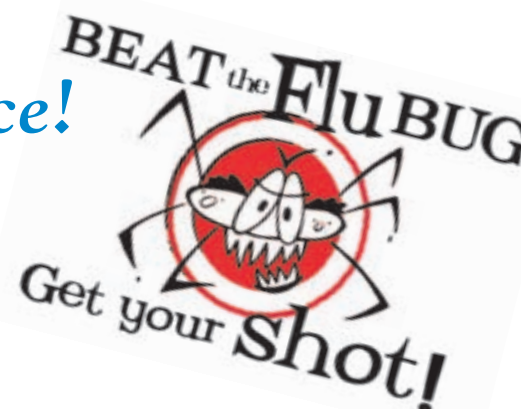

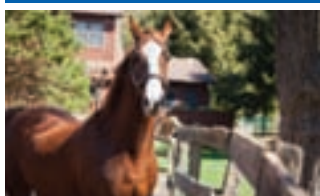

The packaging process involved groups of six people at each table measuring and pouring food into bags, which were then placed in a bin. Everyone would rotate and switch measuring jobs throughout the morning.

"It's really interesting because everyone switches jobs," said third grader, Zoe Vegabravo.

Once the bin was full, a designated runner was called to come and run the bin over to the sealing tables.

Sealing the bags was the most precise job of all. The ends of the bag had to be lined up perfectly in order for a tight seal.

Once this job was complete, a runner would take the bin of sealed bags to the packaging area. Here, the bags were counted and placed into boxes, which were then lifted onto the Stop Hunger Now truck.

Fran Stark, Associate Pastor from the Chapel in the Pines, said, "It's wonderful. It's exciting to see this number of people come together in the community to stop hunger."

The churches were topped their goal of paying for and preparing 60,000 packaged meals, with a final total of 63,500.

# From harvesting peaches to harvesting the sun

David and Emma Jean Wilson built their home in 1995 on family land near the intersection of NC Highway 211 and Hoffman Road. They have harvested, peaches, tobacco, soy beans, trees, and pine straw.

Now they want to harvest the sun, by placing a commercial solar farm on a por-

tion of their land.

The Moore County Board of Commissioners voted to allow solar farming earlier this year. But the Wilsons' land lies within Foxfire Village's extraterritorial zoning jurisdiction. Foxfire's Planning and Zoning Committee is currently developing recommendations for the Village Council on whether to allow solar farms.

David Wilson is not new to land management. He has served twice on Moore County's Land Use Plan Steering Committee and helped write the Small Area A Land Use Plan.

"I know enough that it could be done with a conditional use permit," Wilson said. "You have in place a reclamation bond." A reclamation bond would ensure the removal of the solar panels if and when they ever became inoperable.

Wilson lives on the land that he and his brother grew up on. Their father and grandfather moved to Moore County a hundred years ago to farm peaches. For the rest

of their days, their livelihood was peaches.

"They came here in 1912 to grow peaches," Wilson said. "My grandfather, father, and uncle were in business together. They also mined sand."

"It was a big enough operation that they packed two refrigerated cars of peaches a day," he said. The railroad track backed right up to the Wilson property to pull out carloads of peaches and sand.

After Wilson's father died, in the 1960s, he convinced his mother to plant longleaf pines. He began to extensively manage the family land after his retirement from the Air Force in the 1980s.

Driving the the narrow sandy lane that was once the railroad bed, Wilson pointed to a stand of young pines.

"I started burning to push back the scrubby blackjack oak," he said. "A longleaf pine forest needs fire. They are fire tolerant, and a very young pine can withstand fire, if you burn before the candle comes out," Wilson explained. [The candle stage is when a longleaf tree matures past the grass stage.]

"I do early growing season burning. It produces a lot of grass. Young quail take cover in the grass, eat grasshoppers... It's all connected." In

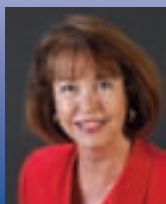

to satisfy the pickiest child or adult.

"We have flavors from fruity tutti, to wild coconut, to chicken pot pie," Barrett said.

Because the compounded products are made from scratch, expensive non-active ingredients within a prescription can be substituted for less expensive fillers.

"None of this is going to work if the patient can't afford to get it," Demarest said. "The nice thing about compounding is that I can say to the customer, 'You know, it's because of this ingredient that it's so expensive. Let's see if we can use something comparable [that is less expensive].'"

### From pill to cream to gel to lollipop

The Prescription Shoppe can take medications which are taken orally and transform them into a medicated cream or other forms.

"If someone can't take a specific medicine because they have kidney or stomach

issues," Demarest said, "we can put the medication in a topical cream. This way it's not being put through the entire body; it's actually isolated to the one spot they're using it on. It's not going to go into their stomach and upset it."

"We had a patient about two or three weeks ago who was prescribed gabapentin for nerve pain and diabetic neuropathy," Barrett added. "He was taking that by mouth in a tablet form, and it caused sedation to the point where he couldn't function properly; he was just so drowsy. So we took it and made it into a topical cream. Now he's doing fantastic."

"A lot of hormones are not effective when taken by mouth," Demarest continued. "So a lot of women are relying on creams for them to get the full benefit."

"That's a big market," Barrett added, "just because of menopause and just the things that women go through and all the effects of menopause that they expe-

rience. . . We make estrogen, progesterone, and sometimes testosterone creams to help with the effects of menopause and PMS."

Compounding allows The Prescription Shoppe, working with the patient's doctor, to craft bio-identical hormones for the treatment of menopause symptoms.

"All of [our bodies] make pretty much the same hormones," Barrett said, "but what we're looking at is we want to supplement the exact molecule that your body makes. So, if you compare the two molecules together, what we have in the compound to what your body produces, they are bio-identical, meaning that they are

exactly the same."

A cream isn't the only new form a medication can take.

"For patients who have herpes [or fever blisters]," Demarest said, "instead of taking these giant pills that they have to carry with them everywhere, we can put the medication in chap stick or a lollipop, so it's not this obvious thing."

"There is a potential to make medications for hospice patients who can't swallow," Barrett said. "We can make a gel that can be put in a syringe squirted into their mouth . . . It's much easier for them to swallow and it's absorbed through the oral mucosa. We can put medications in there like anti-

anxiety drugs or even pain medications."

### An investment in training & equipment

Barrett and Demarest made sure that they had sufficient training before they opened the new lab. They went to the PCCA [Professional Compounding Centers of America] in Houston, Texas for a week over the summer to learn the compounding process.

"They have a really great staff with people from all over the country and even all over the world," Demarest explained.

The PCCA is also the source for most of the Prescription Shoppe's chemicals.

The PCCA's chemicals go through an "extensive testing process," Barrett said, "If they feel that it's not up to their standards then they reject it."

Barrett and Demarest take pride in their work and invest their energy in ensuring the safety of their patients.

"One quality control we have," Barrett said, "is the ability to connect our balance where we weigh our chemicals out to our computer software system."

"Say if Jenn weighs out a chemical on our balance, it links directly to the software and prints out so that the pharmacist can accurately check that. So I know exactly how much she's weighed out. She has to scan the barcode of the product, so I know she's using the right product and the correct amount. That's another thing that I'm

really proud of — that we have control measures like that for safety."

"[The system] will not let me continue if the weight is not correct," Demarest said, "and that makes me feel better cause then I know when that medicine goes out that it is exactly what they were supposed to have."

Other new lab equipment includes an electronic mortar and pestle which electronically mixes creams.

"It makes sure that it's consistent," Demarest said, "versus me hand mixing something. It will consistently mix, and you know it is even throughout."

"We also have an ointment mill [that] we put our creams through," Barrett said. "It actually reduces the

particle size of the chemical. In reducing the particle size, it makes it better absorbed through the skin."

The Prescription Shoppe's new compounding lab swung into action on August 1.

"We pride ourselves in producing something that's quality," Barrett explained. "And we want patients to understand that too. It's specifically made for them; the whole process is customized for them."

## Other Business

In other business during their Tuesday, September 16 meeting, the Moore County Board of Commissioners:

- Received a presentation from Department of Social Services Director John Benton, who proposed an upgrade to the department's systems that would allow social workers to use iPads, rather than paper files, when doing field work. Benton said the \$331,000 project will save the department \$117,100 in the first year.
- Approved a resolution that commits the county to join with the Villages of Pinehurst and Foxfire in a coordinated planning effort for the NC Highway 211 corridor from West End to the Pinehurst Traffic Circle. Commissioner Jimmy Melton asked to serve as the county's representative on the panel and suggested that he had a citizen representative to recommend, as well. Appointments to the committee were tabled to the Commissioners' October 7 meeting.
- In a four-to-one vote, with Commissioner Picerno opposed, approved a resolution asking the NCACC to include in its legislative goals the "restoration of funding to the State Aid to Public Libraries Fund to the pre-2011 level of \$15.7 million."
- At the suggestion of Commissioner Picerno, approved a resolution opposing a redefinition of

"waters of the United States" proposed by the Environmental Protection Agency and the Army Corps of Engineers. The National Association of Counties, which Moore

County recently joined, argues that the proposed definition is overly broad and could result in increased costs to county taxpayers.

- Approved amendments to

two contracts for the Glendon-Carthage Road fire-EMS substation. The first adds \$6,000 to a \$149,725 contract for the installation of a sprinkler system. The second adds \$55,000 to a \$91,932 contract for site preparation.

- Approved a version of the Partners in Progress funding agreement that had been edited by Partners attorney John May.

- Appointed interim finance director Caroline Xiang to the Juvenile Crime Prevention Council.
- Awarded the contract for the county's Wellness Works employee health clinic to FirstHealth of the Carolinas.

a clearing stands a little quail hut for field trials. "I work to keep it in its almost original state," Wilson said.

Fire caused by lightning once kept the forest healthy. With suppression of fire the scrubby undergrowth takes over. Prescribed burns actually help prevent forest fires in the Sandhills. Wilson earned his burn certification to conduct prescribed burnings.

"I don't clear cut timber, but do selective cutting in very small areas," Wilson said. The tall stands of pines and native wire grasses are serene and quiet. Pointing to a stand of twenty year old trees, he said, "Some of those are destined to be telephone poles. It takes a long time to grow a light pole."

At the edge of the pits from which sand was harvested, Wilson said, "When we started out with Strata Solar, we were looking at putting the panels where the sandpits

are, but the lay of the land was wrong. The panels need to face south. We regrouped and decided to move the panels next to the pits."

The proposed solar farm would require only thirty five acres and, given the size of the Wilson property, the location is only visible from the air. Hundreds of acres would buffer the solar installation from neighboring properties and roadways. The adjacent land is owned by Wilson's brother. Together the Wilsons share over 756 acres.

Wilson might be considered a common sense environmentalist. He makes use of the natural resources around him. He heats his house in the winter with a wood burning boiler. When he cleared out the scrubby black jack oaks from beneath his pines, he didn't pile and burn the debris or send it to the landfill. Instead, he gave it away for firewood and kept some to fuel his furnace. He has a solar-powered electric fence

to keep the deer out of the garden. He rakes up the long-needed pine straw and sells it by the bale.

The former sand pits have been sculpted into a gentle rolling depression that attracts wildlife. He no longer has to plant trees — with controlled burns, nature does it for him. Several stands of young trees were seeded by the wind.

The hill where the Wilsons built their home offers a panoramic view of Moore County.

"I used to notice it was hot down there and cool up here," Wilson said. "The fields created a thermal. We built our house up here for the nice, cool breeze. It's called a 'viewshed.' I used to be able to see all the way to Camp Mckall before the pines grew too tall. The trees also screen where the solar farm panels would go."

Emma Jean Wilson's painting studio overlooks their land. It can be inspirational

to an artist. She has worked with different mediums and currently is working with jeweled vibrant alcohol inks. One of their son's lives nearby and works with Wilson.

The Wilson family cares for their land, and their land

has provided for them for over a century. Now they have the opportunity to harvest the sun and provide energy to their neighbors.

As Wilson said, "It's all connected."

### A little length adds a lot of boat

Director Steve Ritter asked how big an impact it has to increase boat length by a foot.

"My question is — and I am not boater, so I am trying to grasp this — how much more wake is 12 inches going to give?"

"A lot," Temple replied. "That 24 foot boat has standing head room. The empty gross weight is 5600 pounds. Add 50 pounds of gas and 12 people and you have an 8000 pound boat. The weight will be significantly more. It also gets wider with the length."

"You don't find many ski boats more than 20 feet long," Fentzlauff added. "They get too big for what they are designed to do."

"It's when they start going over to ocean size, they are designed heavier to cut through rough ocean swells and the wake is going to be bigger. They are heavier and they are going to have cabins in them. You can stand up full height without hitting your head."

"You use a boat like that with a cabin on it to take it down a river and stay overnight at a marina. They have a bed, toilet, sink, stove — we talking a totally different class of boat when they go over 23 feet. The lakes are not big enough to handle a boat that size."

President Bob Racine made a motion to send the proposal for increased boat length to the open meeting for a vote, apparently seeking a "No" vote that would move the matter off the board's to-do list.

The motion died for lack of a second, having the desired effect. The maximum boat lengths will remain 17 for a ski boat and 23 for other power boats.

### Facilities plans need recreation review

Member Les Sommers expressed his concern that tentative drawings of the proposed work on the pool and tennis courts have been made public, when the projects have not yet been approved by the board.

But preliminary bids are being solicited for the projects.

"We have received two bids to date," Sohl reported.

Sommers also noted that the Recreation Committee has not been asked for input on the work.

"Why doesn't Mary's [Farley] committee have something to say about pools and tennis courts?" he asked.

Farley confirmed that that the Recreation Committee had not yet been approached.

"I only heard of plans through other members," she said. "I haven't been asked, and I have had no input."

The plans were discussed during the August 27 SLLA

open meeting. Farley was not in attendance.

"We have voted on nothing," President Racine said. "I haven't even been shown the changes. It seems the Facilities Committee took away all the power of review. The Recreation Committee should meet with Facilities and discuss it. What Les says is true. After that it will go before the community."

### Other business

In other business during the Monday, September 8 Work Session of the SLLA Board of Directors:

- The stables bathrooms are in need of replacement Mary Farley reported. "They are not dirty. They are just old," she said. "They need to be fixed or totally replaced." Handicapped accessible porta-johns will be in place for the Prancing Horse Program that is scheduled to start in several weeks.

- Manager Sohl recommended that members using SLLA facilities and serving alcohol purchase a liability policy to cover the risk. The board voted unanimously to table the proposal for further review.

- Lightning from a recent

storm knocked out the front gate cameras at Seven Lakes North. Insurance will cover the expenses.

- Two members back due

accounts are considered uncollectible due to foreclosure. The recommendation is to write off the aged balances.

into raises for teachers.

Because the district must open schools and continue to operate regardless of how long the legislators in Raleigh drag their feet, Griffin had prepared — and the board had approved — a provision budget that anticipated \$64.4 million in state funding.

But the state instead came through with \$68.2 million, a 4.6 percent increase over last year and \$1.1 million more than the state provided in FY 2009, the last year before the Great Recession.

However, in FY2009, Moore County had 12,190 students. It now has 13,074. So per pupil state funding amounts to \$5,216, compared to \$5,508 in FY2009, a 5.3 percent decrease.

Board member Ed Dennison objected to continuing to compare current spending levels with those in FY 2009.

He noted that “virtually all of the hurt” came in budget cuts imposed in FY2010.

“That wouldn’t be a fair representation of the impacts we have felt,” Griffin replied.

“I’d like to be positive about it,” Dennison said, “we are making progress . . . I would like the community to be aware that we are making progress.”

“I think it’s great to see where we have come from and where we have been,” board member Laura Lang said.

“We are still not back up

to where we were in per pupil funding.”

### Raises for teachers

A key objective for the General Assembly in crafting its education budget was to increase teacher salaries. There has been considerable press coverage and public pressure concentrated on the state’s low ranking on teacher pay.

Griffin said the new pay scale enacted in the budget will give teachers who have five to nine years of service a sixteen percent raise, to a salary of \$36,500.

Teachers with one to four years of service received a seven percent raise, bringing their salaries to \$33,000.

Teachers with ten to twenty nine years of service will receive raises of five to seven percent. Those with thirty or more years of service received no raise, but were given a \$1,000 bonus.

Principals and assistance principals received a two percent raise and other employees received a \$500 bump.

### Cuts elsewhere

What hasn’t changed with the new state budget is a loss in local district flexibility that dates to the FY2013 budget year.

Griffin explained that the state provides Moore County with funding for a set number of classroom teachers. The dollar amount is based on the statewide average teacher

salary. Moore County teachers, on average, make less than the statewide average, which means not all of the state money allocated for classroom teachers is used.

MCS was once able to take those savings and use them to hire more teachers. Beginning in FY2013, that flexibility was taken away, and the savings revert to the state.

The number of teachers the state allocates for the district has also declined over

time, Griffin said, even though the number of students has increased. In FY2009, the district had 12,190 students and 580 state-allocated teaching positions. In FY2015, 575 teachers will be responsible for 13,075 students. That’s five fewer teachers for 884 more students, Griffin said.

Funding for teacher assistants has also be cut, from \$4.4 million in FY2013 to \$3.1 million in FY2015. Seeing the handwriting on the

wall, MCS had already dropped teacher assistants in second and third grade classrooms shortly after the economic downturn in FY2009.

“That’s a thirty percent reduction since 2013,” Griffin said. “What that means is that more adjustments are needed in this area.” He said that MCS administration would work with principals on the issue and eventually

bring a recommendation back to the board for changes in FY2016.

The new state budget eliminates driver education funding beginning next year, in FY2016 — a \$230,000 cut to the MCS budget. Griffin said this was a clear example of the state shifting expenses onto local districts.

Additional cuts have reduced the allocations for assistant principals, as well

as instructional and non-instructional support staff. State funding has been reduced for instructional materials, textbooks, and technology, Griffin said.

"You can go to any school, talk with any principal, any teacher and they will tell — and they will be accurate — that they are doing more work with less," Griffin said. "And they are doing an amazing job."

### Pressure on fund balance

MCS' FY2015 budget includes spending \$2.8 million of the district's \$8 million fund balance. The "fund balance" can be thought of as MCS' savings account of "rainy day fund." It's the cumulative savings the district hangs onto from year to year.

That savings account got a big bump in FY 2011 and 2012, when the American Recovery and Reinvestment

Act — the "stimulus" — temporarily increased federal funding to MCS. The district held onto most of that money rather than spending it right away.

Peaking at \$12.4 million in FY 2012, it has declined faster than expected due to state cuts.

Last year, MCS planned to spend \$4 million of its fund balance, but actually spent only \$1.7 million.

### Stable federal and local funding

Both federal and local funding are expected to be "relatively stable," Griffin said.

Federal funding, the bulk of which is targeted for specific purposes, like programs for exceptional children, is

budgeted at \$6.3 million. Last year, that total was \$6.8 million, and Griffin told the board that he expects, once the federal fiscal year begins in October, the the "conservative" \$6.3 million budget will rise.

Local funding is up \$488,000 compared to last year, at \$27.1 million. That includes \$600,000 in funding for the district's digital learning initiative, which will ultimately put a laptop or tablet computer in the hands of every student.

Griffin noted that the \$27.1 million does not include loan payments the county will make on voter-approved school bonds, which bring the total local outlay to \$32.5 million.

in leasing it until after the School Board's action" declaring it surplus.

### Frustration at the process

Though the commissioners had no comment on the possibility of a STARS lease or purchase of Academy Heights, Chairman Larry Caddell expressed frustration that the state constitution ties the hands of counties when dealing with surplus school buildings.

"I think it is absolutely ridiculous that we have to reject a property that we paid for in the first place," Caddell said. "Just because it's in the constitution doesn't make something right. But we will never buy back something that we had to pay for in the first place."

"The law does give the school board many more options that we don't have," Caddell said.

Both he and Commissioner Randy Saunders expressed

a desire to see any funds MCS derives from the sale of the property channeled back into the construction of new school facilities.

"I tracked a vehicle doing 58." He recommended inviting the police to come in and patrol or have Westside security use a radar gun, write down the tag numbers, and send the offender a fine.

"That is actually one of the ideas we are looking at right now," Herdrich replied. "Have a roving patrol with a radar gun and record license plate numbers. Gated communities Woodlake and Pinelake both do it. We have to make sure we can do it legally."

## It's about enforcement

During the discussion that followed, most all members in attendance seemed to agree that speeding is an enforcement issue; and unless speeders and tailgaters are penalized, they will continue to do both.

"I have been here two years, so I am fairly new," another member said. "My wife and I have this discussion fairly often. We have never seen such speeders; and along with speeding, comes tailgating. I was doing 35 and someone behind me was tailgating hard."

"I have been wanting a new car any way," he laughed. "I don't think it is a matter of the speed limit signs. No one is paying attention to them anyway. No matter what you put on them they are going to speed. It is an enforcement issue."

"If we keep crying wolf no

one is going to pay attention," he continued. "It seems as though there should some sort of embarrassing notification. Why not put their tag or name up on the website? What's it going to take? Someone to get run over or a child to get killed? We need to post it in the newsletter and start naming these people."

Herdrich said he wasn't sure about the legality of publicizing an offender's name and photo.

Other ideas floated during the meeting included speed bumps, which were thought to be effective but expensive. Another resident suggested roundabouts or small traffic circles at intersections to control speed. Another resident recommended updating signage.

In addition to having the Association issue speeding tickets, Herdrich suggested turning off the barcodes of speeders.

"Check people who are speeding and start turning their barcodes off," he said.

"If a guest is speeding, the member will also have his barcode privileges revoked."

Another member noted that the Moore County Sheriff's Office is already stretched thin.

"The reality is, they will tell you that they cannot afford policemen to be tied up in traffic court," he said. "They don't have the manpower. We are going to have to enforce it ourselves."

## Longleaf is dangerous

Longleaf is a winding residential street. Many of the homes have hidden driveways.

"The house next to me is for sale," one member said. "We have heard people say we don't want to live on Longleaf because of the speeding. The ones that so egregiously speed are not going to be shamed. They are the ones that need some sort of a real consequence."

SLWLA Director Mercedes Herdrich pointed out that pedestrians and parents

should be aware that, even when drivers drive the speed limit, it can be dangerous.

"Longleaf is 35 miles per hour," she said. "I don't think any child should be on Longleaf. Longleaf is major road. I live on Longleaf and do my walking on side roads."

Former Director John Goodman said he was recently run off the road by a speeder.

"The car was speeding at least 50 miles per hour," Goodman said. "I had to pull off. He was a vendor. We should have clear penalties for subcontractors and vendors. They need to be informed. Many are respectful, and some or not. If they are caught speeding they could be barred from the

community."

## Solutions come with a price

Mercedes Herdrich, who serves as the Association's treasurer, reminded members that many of the recommendations being proposed would need to be worked into the budget.

"There are a lot of good ideas being thrown around," Herdrich said. "But, as the finance director, this is going to cost money; and there is nothing in the budget for it."

"I don't have a problem with raising dues to cover it," she added. "But you have to remember: over 400 people voted no to raising dues by \$5 a month. Everything boils down to money. Before we

and Zoning Committee. They need to sit down and work with the property owners to figure out the zoning."

"We don't want the situation now that we have had before. It's a priority that P&Z have the property zoned by December."

The newly-annexed section of Grande Pines includes lots that are 2.5 acres and up.

Small lots are permitted in the Village's Equestrian zoning district; however, a property owner must own six acres or more to keep horses.

"The way Grande Pines has evolved it has worked well for the village and is a really good tax base," Mace said. "It has been the village's flexibility that has allowed it to evolve that way: large horse farms and 2.5 acre lots. We

agreed not to do anything less than 2.5 acres."

"As far as the zoning, my intent is that everything will be brought in as RS-40," Mace continued, referring to a residential zoning district that allows lots of one acre or more.

"If homeowners want to have a horse farm, then they will have to combine consecutive lots to equal six or more

acres," he continued. "The majority buying land right now are people who want a little elbow room. In this economy, there's not a lot of people that have enough disposable income to have horses."

Village Mayor Steve Durham recommended that in the future zoning to be recommended and included in any future annexations.

"We should do it simultaneously," he said.

### Protecting the village water system

To help prevent contamination of the village's potable water supply, the NC Department of Environment and Natural Resources [NCDENR] recommended that the village educate the public regarding backflow prevention.

Backflow occurs when there is a reversal of the flow of water in the system, such that untreated water — and

put all the stuff on the table, we have to find a way to budget for it."

Several members noted that patrolling and ticketing would involve little extra cost. Fines would also help offset expenses and possibly fund signs and speed bumps.

### Other security issues

Mick Herdrich opened the floors for other concerns. One member expressed her concern with the lack of fencing at the front gate. Mercedes Herdrich assured her that new fencing would soon be installed.

Another concern was fishing by unauthorized individuals. Herdrich reminded everyone that Beacon Ridge Country Club is open to the public.

"If someone says they are going to Beacon Ridge or to play golf we have to let them in," he said.

One member suggested hangtags of different of different colors. Herdrich noted that hangtags were discontinued due the expense and ineffectiveness as many guests often forget to hang them.

One resident reminded

everyone that guests should feel welcomed.

"I also want my visitors and your visitors to be met with good southern hospitality," she said. "I came here, and it felt like home — and I want my guests to have the same feeling when they come and neighbors to treat our guests with respect."

any contaminants it might contain — are drawn into the municipal water system.

The most common problem of this type is when a home has both a connection to the village water system and to a private well, whether used for irrigation or, prior to tapping onto the village's system, for household water.

"We don't necessarily have a good ordinance, and the state requires certification," Councilman Jon Sedlak explained, "and we either need to build a form or they will provide it to us. We also need to draw up an ordinance with the suggested procedure, making sure these things do get filled out and follow up for our annual certification."

Sedlak said he believes the chance of contamination is low.

"Everybody has a check valve at their meter," he said. "There are different levels [of valve] to prevent contamination. With irrigation, you need an RPZ [reduced pressure zone] valve — a simple check valve is not sufficient."

"We put in the ordinance three years ago: if a resident has a well, then we require them to put in a double check valve on the line coming from the main to the house and from the meter box to the house, in case you do accidentally do hook up the house to a well," Sedlak said.

Durham encouraged Sedlak to work with Village Clerk Lisa Kivett to refine the relevant village ordinance to meet NCDENR's requirements.

"Between now and the next work session stop in and see Lisa and pull up some samples of similar ordinances that you might be able to modify," Durham said.

### NCDOT nixes lower speed limit on Hoffman Road

The village recently asked the NC Department of Transportation [NCDOT] to consider lowering the speed limit on the portion of Hoffman Road that lies within the corporate limits.

Koos reported that NCDOT's response is that they actually would prefer to raise the speed limit to 45 mph.

"I asked about West End [which has a 35 mph limit], and DOT said that was done 20 years ago, and that the speed limit should be raised

there, too," Koos reported.

NCDOT's recommendation is based on past traffic studies.

"They did some traffic studies and looked at the historical data and whether it was appropriate to decrease the speed limit," Durham reported. "I am of the opinion, based on that particular correspondence, that we leave it alone and address it internally. It's not worth the effort. They have made it clear that they are not interested in lowering it."

Frusco expressed her displeasure with NCDOT's recommendation.

"I have a strong objection," she said. "It is not acceptable. We will have to figure it out for ourselves, if we can't get NCDOT to help us."

### Solar farm presentation

Representatives of Strata Solar, a North Carolina-based company specialized in large scale solar power installations, are scheduled to attend

the council's Thursday, September 18 Work Session to answer any the Council's questions about solar farms.

In January, David Wilson, who owns several hundred acres at the intersection of Hoffmann Road and NC Highway 211 requested a conditional use permit to construct a solar farm on his land.

The thirty-five acre installation would be completely concealed within his acreage, but the village's zoning ordinance does not address commercial solar installations.

### Burning permits

Earlier this year, several Foxfire Village residents had requested permission to burn debris on their property, prompting the Council to revisit the village ordinances on open burning.

The Planning and Zoning Committee has completed its first draft of a proposed ordi-

nance and forwarded it to the Council.

During the September 9 meeting, Councilman Mic McCue encouraged the Council to look it over and forward any comments to Planning and Zoning Chairwoman Mary Gilroy.

### Pesky woodpeckers

Woodpeckers have been busy boring holes into trail signs, Councilman Vic Koos reported.

"The trail signs are a mess," he said. "The trailhead sign also has the wrong distances for each section."

Koos recommended replacing the signs.
